Note: i) Conventional type applications will be summarily rejected. Candidates shall apply only through online application facility available at the Kerala Public Service Commission website viz. www.keralapsc.gov.in

- ii) Applications submitted by candidates belonging to the communities other than those notified will be summarly rejected. Individual rejection memo will not be issued to these candidates.
- iii) A Ranked List will be prepared for Pathanamthitta district by the Commission. It shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post on 05.06.2012 in Pathanamthitta district as category No. 258/08.
- iv) Candidates shall submit application for the post to Pathanamthitta district where the vacancy is in existence for their community and shall note the name of that district against the relevant column in the online application.
- v) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O. (Ms) No 154/71/PD dated, 27-05-1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O (MS) No. 4/61/PD dated 02.01.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
