4 Method of Appointment : Direct Recruitment (Special Recruitment from among Scheduled Castes/Scheduled Tribes and Scheduled

Tribes only)).

Note:- Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

5 Age : 19 - 49

Only Candidates born between 02.01.1969 and 01.01.1999(both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

6 Qualifications:

- (1) Pass in SSLC or its equivalent qualification.
- (2) (a) National Trade Certificate in the appropriate Trade

OR

(b) National Apprenticeship Certificate in the appropriate trade

OR

(c) Diploma in the appropriate branch of Engineering from a Government or Government recognised Polytechnic or its equivalent examination.

Note:- 1. Rule 10(a)(ii) of Part II of KS & SSR is applicable.

- 2. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- 3. If the caste of the candidate is wrongly mentioned in their SSLC book, but they have claimed their original caste in the application, should produce community certificate issued from the concerned revenue authority along with the Gazette Notification of the same at the time of certificate verification.

7 Training:

Only those who have successfully completed training from Central Institute shall be eligible for promotion. However the eligibility of those who have not been deputed for training by Government for no fault of theirs will not be affected if they are otherwise qualified for promotion but such persons should undergo training after promotion.

8 Mode of Submitting application:

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have already registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registeration Candidates are responsible for the correctness of the personal information and Card. secrecy of password. Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. "Candidates who have Aadhar Card should add Aadhar card as I.D Proof in their profile ".
