Applications are invited only online exclusively from qualified candidates belonging to Muslim community of Kerala State for appointment in the undermentioned post in Kerala Government Service. Before applying for the post the candidate shall register as per One Time Registration Scheme through the official website of Kerala Public Service Commission.

1. Department : Medical Education
2. Name of Post : Rehabilitation Technician Gr.II  
(Leather Works)
3. Scale of Pay : ₹ 20000-45800
4. Number of vacancies : Muslim- 1 (One)

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until a candidate is advised and appointed against the above vacancy earmarked for the above mentioned Community but remains unfilled and also against the vacancies that may arise due to the paucity of candidates belonging to Muslim Community during the currency of the Ranked List published on 25.01.2017 for the post (Cat. No. 005/2014).

5. Method of appointment : Direct Recruitment (From candidates belonging to Muslim Community only)

**Note:-** Applications submitted by candidates belonging to community other than the above mentioned community will be summarily rejected. Individual communication regarding rejection of their application will not be issued.

6. Age limit : 18-39, only candidates born between 02/01/1979 and 01/01/2000

(both dates included) are eligible to apply for this post.

(Including the relaxation as per para 2 (i) of the General Conditions)

[For other conditions regarding age relaxation please see Para 2 of the General Conditions, except para 2 (I)]

**Note:** Persons who have undergone successful Training in the Artificial Limb Centre attached to the Medical College, Thiruvananthapuram under the Half a Million Job Programme will be eligible for relaxation of five years in the upper age limit.

7. Qualifications:-

- 1 Pass in SSLC
- 2 Candidates who have completed Certificate Course in Prosthetics & Orthotics conducted in the Institution recognized by the Rehabilitation Council of India.

**OR**

Bachelor Degree/Diploma in Prosthetics and Orthotics conducted by institution recognized by the Rehabilitation Council of India

**In the absence of 1 and 2 above**

- 3 Candidates who have successfully completed ITI Trade in Carpentry, Sheet metal and Fitter. On appointment they will be considered trainee for one year and they will be given the salary of minimum of scale of pay of the post.

Note:- 1. K S & SSR part II Rule 10 (a) ii is applicable.

2. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

3. in the case of difference in original Caste/Community claimed in the application and that entered in SSLC book ,the candidate shall produce a gazette notification in this regard, along with Non Creamy Layer Certificate/Community

Certificate at the time of Certificate verification.

**8. Mode of submitting Application:-**

- (a) Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2010. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a print out of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application , candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, community, age etc. have to be produced as and when called for.
- (b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- (c) Candidates who have Aadhaar Card should add Aadhaar Card as ID Proof in their profile.
