FIRST NCA NOTIFICATION

Applications are invited online only through One Time Registration facility from the qualified candidates of Scheduled Caste community of Kerala State for appointment in the under mentioned post in Kerala Government Service.

1. Department : **National Cadet Corps (NCC)**
2. Name of post : **Boat Keeper (from among Ex-Servicemen/ Disembodied Territorial Army Personnel only)**
3. Scale of pay : **Rs. 17,000 – 37500/-**
4. Number of vacancies : **Scheduled Caste – Kottayam – 1 (One)**

Note:-

- (i) *Applications submitted by candidates belonging to the communities other than those notified will summarily be rejected.*
- (ii) *In case of change in Caste/community noted in the SSLC book, candidates must claim their original caste /community in the applications and shall produce Caste/Community certificates as the case may be issued by the Revenue authority and the original Gazette notification publishing the change of caste/community at the time of OTR verification for selection to the above post.*
- (iii) *A Ranked List will be prepared for Kottayam district in pursuance of this notification. The Ranked List thus prepared and published as per this notification shall remain in force for a period of 3 years or until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district which ever is earlier.*

(iv) *The selection in pursuance of this notification will be made on Revenue District basis, subject to the special conditions laid down in GO(MS) No. 154/71/PD dated, 27.5.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5years continuous service from the date of commencement of service in the former District. Even if transfer is allowed after 5 years, it will be subject to the rules in GO (P) No 36/91/P&ARD, dated 02.12.1991. Candidates already in Government Service holding the same post in any one district are prohibited from applying in response to this notification, but they can apply to higher posts when notified.*

5. Method of appointment : Direct Recruitment (From among Ex-Servicemen/ Disembodied Territorial Army Personnel belonging to Scheduled Caste community only).
6. Age limit : 21 – 50 Candidates born between 02/01/1968 and 01/01/1997(Including both dates) only are eligible to apply for the post.

(For other conditions regarding the age relaxation please see Para II of the General conditions except para2 (1))

7. Qualifications:

- 1) Literacy in Malayalam, Tamil or Kannada.
- 2) Must know Swimming
- 3) Must possess good Physique
- 4) Knowledge in simple Boat handling

Desirable:-

(a) Previous experience as Boat Keeper

(b) Knowledge in Painting and Maintenance of boats.

Note:-

- i) Those who claim equivalent qualification shall produce the respective Government Order to prove the claim at the time of One Time Verification or as required by the Commission.
- ii) Differently Abled candidates are not eligible to apply for this post.
- iii) KS&SSR Part II Rule 10 a (ii) is applicable for selection to this post.

9. **Method of submitting applications:-**

- a) Candidates must register as per “ ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.
- b) If a Written Test/OMR Test/Online Examination is conducted as a part of the selection candidates shall submit a confirmation for writing the examination through their one time registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and availability of Admission tickets will be published in the Examination Calender itself. Information in this regard will be given to candidates in their respective profiles and in the mobile phones registered in it.
- c) Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile.
