- 6** Age limit:-18-39.Only candidates born between 02.01.1979 and 01.01.2000 (both dates included) are eligible to apply for the post.[Including the relaxations in para2(i) of General Conditions.]

7 Qualifications :

- I. Pass in S.S.L.C or its equivalent qualifications.
- II National Trade Certificate in the trade of Electrician
- III Wire man Competency Certificate/Permits issued by the Kerala State Electricity Licensing Board.
- IV Experience in the erection and maintenance of Lifts for a minimum period of 1 year

Note:-

- (1) The experience should be the one acquired after the acquisition of the 1st two qualifications.
- (2) If persons with experience in erection and maintenance of Lifts are not available, persons possessing the other three qualifications will be selected and given training for a period of 6 months in Lift maintenance in the Public Works Department.
- (3) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

9. Method of submitting applications :-

(a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by log in on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.

(b)If a Written/OMR/Online Test is conducted as part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time registration and date of downloading will be included in the examination calendar. Candidates can download Admission Ticket will alone be permitted to attend the examination.
