2 **Name of post** : Field Worker (SR for ST Only)

Note:- (i) The above Vacancy is now in existence. Separate Ranked list will be prepared for each district in pursuance of this notification. The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from ST only during the pendency of the list.

- (ii) The Selection in Pursuance of this notification will be made on a Revenue District basis subject to the special conditions laid down in Go (M.S)No. 154/71/PD dated 27-05-1971. A candidate advised for appointment in one district from the Ranked list so prepared is not eligible for transfer to another District unless he/she completes five (5) years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five (5) years, it will be subject to the orders contained in G.O(MS) No.4/61/PD dated 2.1.1961. Candidates already in Government service holding the post in one district are restricted from applying for the same post in another district. But they can apply for the higher posts.
- (iii) Candidates from the Ranked list for district wise selection will be advised for appointment against the Headquarters Vacancies also. As per provision in G.O (Ms) 154/71/PD dated 27.05.1971 appointment against the Headquarters vacancies will be started from Thiruvananthapuram District. Separate option need not be given for this.
- (iv) Candidates are not eligible to apply for the same post in more than one district. If a

candidate applies to more than one district and gets selected his/her selection will be cancelled and disciplinary action will be taken against him/her.

5 **Method of Appointment** : Direct Recruitment (from among Scheduled Tribes only).

Note:- Applications received from candidates other than the ST candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6 **Age Limit** : 18 – 41, Only candidates born between 02.01.1972 and 01.01.1995 (both dates included) are eligible to apply for this post.

Note:- In the absence of qualified candidates within the age limit, the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 Qualifications:

- i) Must have studied up to VIII Standard or its equivalent.
- ii) Should have good physique and must be free from Physical deformity and diseases of any description

Note:- Physical fitness shall be certified by a Medical Officer not below the rank of an Assistant surgeon (Physically Handicapped persons are not eligible to apply for the post)

8 Mode of submitting application:

Candidates shall register as per 'ONE TIME REGISTRATION' system on the Official Website of Kerala Public Service Commission 'www.keralapsc.org' for applying for the post. Candidates who have registered shall apply by logging in to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link for applying for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile by clicking the link Registration Card, if required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile. They must quote the User- ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove Qualification, community, age etc. have to be produced as and when called for.
