  - Note:- 1) The above vacancy is now in existence. 5. **Age Limit** : 29-46. (Only candidates born between 02.01.1967 and 01.01.1984 (both dates included) are eligible to apply for this post. (No other age relaxation will be allowed.)

**Note:-** In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50(fifty) years.

Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected.
