- 5 Method of appointment : Direct Recruitment
(From candidates belonging to the Scheduled Castes only. In the absence of qualified candidates belonging to Scheduled Castes, candidates belonging to Scheduled Tribes will be considered).

Note:- Applications submitted by candidates belonging to communities other than those mentioned above will be summarily rejected. Individual communication regarding rejection of their application will not be issued.

- 6 Age limit : 20-42. Only candidates born between 02.01.1972 and 01.01.1994 (both dates included) are eligible to apply for the post. The upper age limit mentioned above includes the usual relaxation as per rules.

- 7 Qualifications :

B.Sc in Dairy Science or B.Tech (Dairy Science and Technology) from a recognised University or National Dairy Research Institute under the Indian Council of Agricultural Research (ICAR)

Candidates shall register as per 'ONE TIME REGISTRATION ' system on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates who have registered shall apply by logging in to their profile using their User- ID and password.
