SECOND NCA NOTIFICATION

Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

1. Department : Education
2. Name of Post : LP School Assistant (Kannada Medium)
3. Scale of pay : ₹ 13,210 – 22,360/-
4. No. of vacancies : District wise
Kasaragod - Hindu Nadar – 1 (One)

- Note:- (i) Conventional type applications will be summarily rejected. Candidates shall apply online to the Kerala Public Service Commission website www.keralapsc.gov.in
- (ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued.
- (iii) Separate Ranked list will be prepared for Kasaragod district in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

- (iv) Reservation community candidates shall submit application for the post to Kasaragod district where the vacancy is existing and note the name of that district against the relevant column of the online application.
- (v) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in GO(Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in GO(MS)No.4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (from candidates belonging to Hindu Nadar community only).
6. Age Limit : 18-43 – Only candidates born between 02.01.1971 and 01.01.1996 (both dates included) are eligible to apply for this post in the case of Hindu Nadar.
(Including the relaxation as per para 2 (i) of general conditions)

Note:- For conditions regarding other age relaxation please see para 2 of the general conditions except para 2 (i).

7. Qualifications:

- 1) A pass in S.S.L.C Examination conducted by the Commissioner for Government Examinations, Kerala or its equivalent.

OR

A pass in Pre-degree examination conducted by any of the Universities in Kerala or any examination recognized by any such Universities as equivalent to Pre-degree examination.

OR

A pass in the Higher Secondary Examination conducted by the Board of Higher Secondary Examinations, Kerala or any other Examinations recognized by Government as equivalent thereto.

AND

- 2) A pass in TTC (Kannada) Examination conducted by the Commissioner for Government Examinations, Kerala.

- Special Note :-
- (i) In the absence of candidates with TTC (Kannada) of Kerala, candidates with TCH of Mysore shall be considered for appointment.
- (ii) B.Ed qualification will not be considered in lieu of TTC .
- (iii) Question paper for the written test, if any, will be in Kannada. The candidates should answer the questions in Kannada.

8. SPECIAL CONCESSION REGARDING APPOINTMENT AND AGE LIMIT

- (i) Preference will be given as laid down in G.O.(MS)No.50/70/PD dated 12.02.70 and G.O.(MS)No.9/78/G.Edn. dated 21.01.78 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term 'Jawans'. Wives of Jawans shall select 'Are you entitle to any priority' as 'yes' on online application and give the details in the space that follows. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husband and produce the same as and when required by the Commission (G.O.(MS)No.509/64/Edn. Dated 19.09.1964, G.O.(MS)No.614/65/Edn. Dated 09.11.65 and G.O.(MS)No.243/66/Edn. Dated 27.05.66)

- (ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O.(MS)No.122/75/G.Edn. Dated 27.05.1975 and GO (MS) No. 50/70/PD dated 12/02/1970)

Note:- The candidates who claim concession by virtue of any of the above reason shall select “Are you eligible for age relaxation” as “yes” on the online application and give details in the space following. Otherwise the applications are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule shall not exceed 50 years of age. (See para 2 of General Conditions).

9. Last date for receipt of application : **17/09/2014** Wednesday upto 12.00 midnight
10. Mode of submitting application:-

Candidates must register as per “ ONE TIME REGISTRATION” system on the Official Website of Kerala Public Service Commission viz 'www.keralapsc.gov.in' . Candidates who have registered shall apply by logging into their profile using their User ID and pass word. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details on the registration card by clicking the link **Registration Card** after entering the home page. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile and they shall keep in mind the User Id for further communication with the Commission. Application once submitted will be received as provisional and cannot be deleted or altered on after submission. Applications once submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.
