**Special Recruitment for P.H. (Hearing Impairment, Low Vision) for filling up of 3% backlog vacancies during 2004-07.**

Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

2. **Name of Post** :Assistant Engineer (Civil)
3. **Scale of Pay** :Rs. 20740-36140
4. **Number of vacancies** :PH (Low vision) – 3 (Three)  
**PH (Hearing Impairment) – 3 (Three)**

i).The Ranked List prepared in pursuance of this notification is intended to make recruitment to the backlog vacancies earmarked for the various categories and PH groups as per GO (P) No 7/2011/SWD dated 24/01/2011 and will remain in force for a maximum period of three years subject to the condition that the ranked list will cease to exist as and when candidates are advised and appointed against the above mentioned vacancies. Rules 14 to 17 of Part II, KS&SSR are not applicable to this selection.

ii) Candidates will be advised and appointed against the above mentioned vacancies and also against the backlog vacancies, if any, reported by the Appointing Authorities as earmarked in GO(P) No 7/11/SWD dated 24/01/2011.

iii) Selection to the above-mentioned vacancies will be made from among the (Low vision, Hearing impairment) PH categories found suitable for the post as per existing government orders and vacancies will be filled up from this category. Selection to PH (Orthopaedic Upper/Lower Extremities) had already been notified in the Gazette dated 30.04.2012 as Cat.No. 225/2012).

**5. Method of appointment** Direct Recruitment - only from the candidates belonging to the Category of PH (Low Vision) & PH (Hearing Impairment) through Special Recruitment.

**Note:** *Application submitted by candidates other than those belonging to PH (Low vision, Hearing Impairment) category will be rejected. Individual rejection memo will not be sent to them.*

**6. Age limit** 21-50, only candidates born between 02/01/1964 and 01/01/1993 (both dates included) are eligible to apply for the post.

**7. Qualifications**

(i) B Sc/B Tech Degree in Engineering (Civil) of the Kerala University or B.E Degree (Civil) of the Madras University or any other qualification recognised as equivalent thereto.

OR

(ii) Associate Membership Diploma of the Institution of Engineers India in Civil Engineering or any other Diploma recognised as equivalent thereto.

OR

(iii) Pass in sections 'A' and 'B' of the Associate Membership Examinations of the Institution of Engineers India in Civil Engineering.

**Note:** *KS & SSR Part II Rule 10a(ii) is applicable*

**8. Mode of submitting Application:-** Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is received as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc have to be produced as and when called for.
