FIRST NCA NOTIFICATION

Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

- 1 Name of the firm : Kerala State Development Corporation for Scheduled Caste/Scheduled Tribes Ltd.

Note:-

(1) The above vacancies are existing at present. . The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for SC, Muslim community but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 08.09.2010 for the post. This is the first NCA Notification published due to the non availability of candidates as per the notifications in the Gazette dated 04.09.07 (Category No.290/2007)for the post.

(2)The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post,if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidate,provided that the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made with in the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of Appointment : Direct Recruitment. Candidates belonging to SC and Muslim communities.

Note:- Application submitted by candidates other than those belonging to SC & Muslim communities will be summarily rejected. No rejection memo will be issued to these candidates.

6. Age: SC Candidates
18 – 40 "Only candidates born between 02.01.1974 and 01.01.1996(both dates included)

Muslim Candidates

18 – 38 "Only candidates born between 02.01.1976 and 01.01.1996(both dates included)

Note :

The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

7. Qualification

- 1) Pass in Standard VII(new) or its equivalent.
- 2) 3 years service in the Defence Force.
- 3) Knowledge of Cycling.

Note: Women are not eligible to apply for the post.

8. Mode of submitting applications

Candidates shall register as per 'ONE TIME REGISTRATION' system on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates who have already registered shall apply by logging on to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link to apply for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure the correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove Qualification, community, age etc. have to be produced as and when called for.
