Note:

- (i) In the absence of suitable candidates, the vacancies set apart for By Transfer recruitment shall be filled up by the candidates from the Ranked List prepared for Direct recruitment.
- (ii) The applicant should be an approved probationer/Full member of the Kerala General Education subordinate service.
- (iii) Separate Ranked List will be prepared for each district in pursuance of this notification. The Ranked lists thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the vacancies reported during the currency of the lists. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (iv) Candidates should submit application for this post to the concerned District and should note the name of that District against the relevant column of the online application. Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (v) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the

Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS)No.4/61/PD, dated 02.1.1961. But as per the GO(P) No 12/96/P&ARD dated 16.3.1996 the conditions of 5 years service is not applicable for transfer to Idukki, Wayanad and Kasaragod districts. The concession will be available

only for getting transfer to these districts but not for getting transfer out of these districts. And this condition will be granted only once in the career of a Govt Servant. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

- (vi) The rules regarding the reservation of appointment contemplated in Article 14 to 17 in Part II of the KS & SSR are not applicable to recruitment by transfer.

5. Method of appointment : Recruitment by transfer.

6. Age Limit : Not applicable.

7. Qualifications:-

- (1) A pass in SSLC Examination conducted by the Commissioner for Government Examinations, Kerala or its equivalent.

OR

A pass in Pre-degree examination conducted by any of the Universities in Kerala or any examination recognized by any such Universities in Kerala as equivalent to Pre-degree examination.

OR

A pass in Higher Secondary Examination conducted by the Board of Higher Secondary Examinations, Kerala or any other Examinations recognized by Government as equivalent thereto.

AND

- (2) A pass in TTC (Tamil) Examination conducted by the Commissioner for Government Examinations, Kerala.

OR

A Degree in any subject and B.Ed/B.T/L.T (in Tamil) conferred by or recognized by the Universities in Kerala.

- (3) 5 years service as Clerk/Typist/Attender/Peon in the General Education Department as on the date of application. [G.O. (MS) No. 8/2009/G. Education dated 20.1.2009].

Special Note (i) In the absence of candidates with T.T.C (Tamil) of Kerala and B.Ed (Tamil) holders from the Universities in Kerala, candidates with T.T.C (Tamil) of Madras or candidates with Diploma in Teacher Education (Regular) of Tamilnadu Government shall be considered for appointment.

- (ii) Question papers for the written test if any, will be in Tamil. The candidates should answer the question in Tamil.

Note : Rule 10 (a) ii of part II of KS&SSR is applicable.

quote the User Id for further communication with the Commission. Application once submitted will be received as provisional and cannot be deleted or altered after submission. Applications once submitted not in accordance with the conditions of the notification will be summarily rejected.
