FIRST NCA NOTIFICATION

Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

1. Department : Education
2. Name of Post : High School Assistant (Physical Science)- Kannada Medium.
3. Scale of pay : ₹ 15,380-25,900/-
4. No. of vacancies : District wise

Kasaragod - Scheduled Tribe - 1 (One)

Note:- (i) Applications submitted by candidates belonging to the communities other than ST community will be summarily rejected. No rejection memo will be issued.

(ii) A Ranked list will be prepared for Kasaragod district in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

(iii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he or she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (from candidates belonging to Scheduled Tribe community only).

6. Age Limit : 18-45. Only candidates born between 02.01.1969 and 01.01.1996 (Both dates included) are eligible to apply for this post. [Including the relaxation as per Para 2(i) of General Conditions].

Note:- For conditions regarding other age relaxation please see para 2 of the general conditions, except para 2 (i).

7. Qualifications:

A Degree in the concerned subject and B.Ed/BT in the concerned subject conferred or recognized by the Universities in Kerala. (Concerned subject are specified in Note 3 below.

- Note:-**
1. Diploma in Rural Service awarded by the National Council for Rural Higher Education will also be treated as equivalent to Degree for the above purpose.
 2. If there is a written (Descriptive/OMR) test the Question paper for the written test will be in Kannada. The candidates should answer the questions in Kannada. Knowledge in Kannada will also be tested at the time of interview.
 3. The applicant should have taken physics/Chemistry as main subject for graduation. Degree in Geology (Main) with Physics and Chemistry as subsidiary subjects with B.Ed. Degree (Physical Science) can also be considered as an alternative qualification for the post [G.O (Ms) No 195/96/G.Edn dated 2.7.1996].
 4. Post Graduates in concerned subject with B.Ed/BT are also eligible to apply for the post.
 5. Post title degree holders are not eligible to apply for the post of High School Assistant.
 6. Degree in the concerned subject and B.Ed. mean B.Ed. should also be in the concerned subject.

Note : Rule 10 (a) ii of part II of KS&SSR is applicable.

NB As per orders of the Hon'ble KAT in OA 370/2012 on 19.6.2012, the candidates who have studied both Physics and Chemistry either as main or as subsidiary subjects in degree course alone shall be considered for selection to the post.

8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT

- (i) Preference will be given as laid down in G.O.(MS) No. 50/70/PD dated 12.02.1970 and G.O.(MS) No. 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term `Jawans'. Wives of Jawans should note in the application that they are wives of Jawans. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).

(ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS) No. 122/75/G.Edn. Dated 27.05.1975).

(iii) Teachers of the Government Primary and Nursery Schools who are graduates and are otherwise qualified will be exempted from upper age limit (G.O (Ms) No 185/70/Edn dated 18.4.1970 and G.O (Ms) No 466/70/Edn dt 11.11.1970). They should produce proper certificates from authorities concerned as and when required by the Commission.

Note:- The candidates who claim concessions by virtue of any of the above or any reason mentioned in Para 2 of the General Conditions should state "Are you eligible for age relaxation" as "yes" on the online application and give details in the space following. Otherwise the applications are liable to be rejected presuming that they are over aged candidates.

9. Last Date for receipt of applications : **16.07.2014** Wednesday upto 12.00 Midnight.

10. Mode of Sending Application :

Candidates must register as per " ONE TIME REGISTRATION" on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in'. Those who have registered shall apply by logging on to their profile using their user ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link **Registration Card** . Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile and they shall quote the User Id for further communication with the Commission. Application once submitted will be received as provisional and cannot be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.

11. Address to which applications are to be sent : www.keralapsc.gov.in.

12. If a Written (Descriptive/OMR) Test is conducted as part of the selection, Admission Ticket of eligible candidates will be made available in the website of the Kerala Public Service Commission. Candidates are instructed to download their Admission Ticket as per the instructions in the website.
