Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

1. Name of Firm : Kerala State Road Transport Corporation
2. Name of Post : Assistant Transport Officer(By Transfer - Internal)
3. Scale of Pay : Rs.12060 - 22810/- (Pre-revised scale)
4. No. of vacancies : 8 (Eight)

Note:-

- (1) The number of candidates to be included in the short list/probability list of the above post will be decided as per the availability of admitted applications.
- (2) The above vacancies are now in existence. The list of selected candidates published by the Commission in pursuance of this notification shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new Ranked List after the minimum period expiry of one year is published. Candidates will be advised against the vacancies shown above and for all the vacancies reported during the period of pendency of the Ranked List.
- (3) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of appointment : By Transfer (Internal) (from among other lower categories in the operating branch, ie Conductors, Station Masters and Inspectors)
6. Age :18-45. Only candidates born between 02/01/1968 and 01/01/1995 (both dates included) are eligible to apply for this post.

7. Qualifications:

1. Graduate in any discipline
2. Ten years of continuous service in KSRTC

- Note:** - 1. PH candidates are not eligible for the post.
2. Women candidates are eligible for appointment.

8. Mode of sending application:-

Candidates shall register as per “ONE TIME REGISTRATION” system on the official website of Kerala Public Service Commission ‘www.keralapsc.gov.in’ before applying for the post. Candidates who have registered shall apply by logging on to their profile using their User ID and password. Candidates shall click on the ‘Apply Now’ button of the respective posts in the Notification link for applying for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile by clicking the link Registration Card, if required. Candidates are responsible for the correctness of the personal information and secrecy of the password. Before applying for a post, candidates must ensure the correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application once submitted will be received as provisional and particulars shall not be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found during the course of processing. Documents to prove Qualification, Community, Age, Experience etc. have to be produced as and when called for.
