**Note:** (1) Separate Ranked List will be prepared for each district in pursuance of this notification.

Ranked List thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of new lists after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised and appointed against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked lists till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.

(2) Application should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected his/her name will be removed from the ranked lists and disciplinary action will be taken against him/her. Candidates should note the name of concerned District against the relevant column of the online application.

(3) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O. (Ms) No 154/71/PD dated, 27-05-1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes 5 years continuous

service from the date of commencement of service in the former district. Even if transfers is allowed after five years, it will be subject to the rules in G.O. (MS) No. 4/61/PD. dated, 21.01.1961. Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

**5 Method of Appointment : Direct Recruitment.**

6. **Age Limit** : 18-36, Only candidates born between 02.01.1977 and 01.01.1995 (both dates included) are eligible to apply for this post.

**Note:** - For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part-II of this Notification.

**7. Qualifications:-**

(1) A pass in SSLC or its equivalent qualification

(ii) A pass in Laboratory Technician Course conducted in any of the Medical Colleges in the State or any Institute approved by the Government or under Kerala Agricultural University.

OR

Successful completion of Livestock Inspector Training Course and Training in Laboratory Technician conducted by the Kerala Agricultural University

OR

Diploma in Laboratory Technician Course from Kasturba Medical College, Manipal (South India) for a period of 1½ years

OR

A pass in Laboratory Technicians Course for a period of 2 years conducted by the Secretary, State Council of Vocational Education, Karnataka.

OR

A pass in the Laboratory Technician Course for a period of 1 year conducted by the Dean, Madras Veterinary College, Madras

OR

Class I Laboratory Assistant from Armed Forces Medical College having 15 years experience in the Army Trade of Laboratory Assistant Class I

OR

Ex-servicemen having 16 years of experience in the Army Trade of Laboratory Assistant Class I

OR

Job oriental Pre - University Diploma in H.E. 1-01 Laboratory Technician awarded by Government of Karnataka, State Council of Vocational Education.

OR

Diploma in Medical Laboratory Technology awarded by the Punjab State Medical Faculty  
OR  
A pass in VHSE in Medical Laboratory Technician

**Note:** - Physically disabled persons (Locomotor disability/Cerebral Palsy, Hearing impairment, low vision) are eligible for 3% appointment as per G.O(P)No. 1/13/SJD dated 03.01.2013.

**8. Mode of submitting application:**

Candidates must register as per "ONE TIME REGISTRATION" with the official website of Kerala Public Service Commission viz. [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by log in on to this profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post., No application fee is required. Candidates can view and have a print out of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote the User - ID for further communication with the Commission. Applications submitted is provisional and cannot be deleted or altered on after submission. The application will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.
