- (iv) The candidates belonging to above reservation community shall submit application for this post to the district where the vacancy is in existence for their community and shall note the name of that district against the relevant column in the online application. Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
