FIRST NCA NOTIFICATION

Applications are invited through one Time Registration Programme from qualified candidates belonging to reservation group of SC community of Kerala State for appointment in the under mentioned post.

1. Department : Various
2. Name of Post : Boat Driver
3. Scale of pay : Rs. 9190– 15780/-
4. No. of vacancies : Community wise
Alappuzha – SC - 1 (One)
In the absence of candidates belonging to SC community application of candidates belonging to ST community will also be accepted.

Note:-

- (i) Conventional type application for the above post will be summarily rejected. Candidates can apply through online application available at the Kerala Public Service Commission website viz www.keralapsc.gov.in
- (ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to such candidates.
- (iii) Separate Ranked List will be prepared for above district in pursuance of this notification. The Ranked List thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community but remain unfilled due to the paucity of candidates during the currency of the Ranked List published for the post in the following districts.

- (iv) The candidates belonging to above reservation community shall submit application for this post to the district where the vacancy is in existence for their community and shall note the name of that district against the relevant column in the online application.
- (v) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the

date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS)No. 4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (from candidates belonging to SC community only)
6. Age : 18 – 42. Only candidates born between 02.01.1972 and 01.01.1996 (both dates included) are eligible to apply for this post. (Including the relaxation as per Para 2(i) of General Conditions).

Note:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 (fifty) years, please see para (2) of the General conditions under part II of this Notification (except para 2(i)).

2. Boat Drivers competency certificate granted under the Travancore-Cochin or Madras Canal Rules.
3. Three years experience as Boat Driver.
