- (i) Conventional type application for the above post will be summarily rejected. Candidates can apply through online application available at the Kerala Public Service Commission website viz. <u>www.keralapsc.gov.in</u>
- (ii) Applications submitted by candidates belonging to the community other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.
- (iii) Seperate Ranked list will be prepared for the above districts in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

- (iv) Reservation community candidates should submit application for the post to the concerned district where the vacancy is existing for their respective community and shall note the name of that district against the relevant column.
- (v) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the

rules in G.O.(MS)No. 4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, bu they can apply to higher posts when notified.

- 5. **Method of appointment** : Direct Recruitment (From candidates belonging to above reservation community only.
- 6. Age limit : 18-44 (Including the relaxation as per Para 2(i) of general conditions) Only candidates born between 2.1.1970 and 1.1.1996 (both dates included) are eligible to apply for this post.
  - Note: For other conditions regarding age relaxation, please see para (2) of the General Conditions except para 2 (i). (Subject to the condition that the maximum age limit shall in no case exceed 50 years)

## 7. Qualifications:-

- 1 A Pass in Standard VII/III Forum.
- 2 Must posses valid Heavy Duty Driving Licence of three years standing with endorsement for driving Medium HP & HG Vehicles and Badge. Driving Licence issued after 16.01.79 must have endorsement both for heavy goods and heavy passenger vehicles and the applications with only one endorsement will be summarily rejected.
- 3 Proficiency in Driving Medium/Heavy goods/passenger Motor Vehicles which is to be proved by a practical test including H test and Road test conducted by Kerala Public Service Commission during the course of selection. Only those who have passed `H' test are eligible for Road Test.

Note:- Rule 10 (a) ii of Part II of KS&SSR is applicable.

### Note :-

- (a) Candidates called for practical Test will have to produce a Medical Certificate in the prescribed form in original containing all relevant details as mentioned in item No 4 [except 4 (b) in para 7 above from a Medical Officer not below the rank of an Assistant Surgeon. A Medical certificate regarding eye sight mentioned in 4 b in para 7 above from an Ophthalmologist in Government Service also will have to be produced.
- (b) The Candidates will have to furnish the full details regarding the Driving Licence alongwith qualification in the application.

- (c) Physically Handicapped candidates are not eligible to apply for the post.
- (d) Candidates should possess a current valid Driving Licence and badge on all the stage of selection process namely on the last date of receipt of application, on the date of OMR test, on the date of practical test, interview etc.
- <u>Probation:-</u> Every person appointed to the post shall from the date on which he joins duty be on probation for a total period of 2 years on duty within a continuous period of 3 years.
