2. Name of Post : Tracer
3. Scale of Pay : ₹ 9,940-16,580
4. Number of vacancies : 3 (Three)

The above vacancies are now in existence. 6. Age limit : 18-36, only candidates born between 02/01/1977 and 01/01/1995(both dates included) are eligible to apply for the post. SC/ST/OBC candidates are eligible for usual age relaxation .(For conditions regarding the age relaxation please see Para(2) of the General Conditions).

- i) Pass in SSLC or its equivalent qualification
- ii) Pass in Building drawing and estimating (Higher)
- iii) Surveying and Levelling (Lower)

AND

A pass in any one of the following subjects under KGTE/MGTE

- i) Building materials and construction (Lower)
- ii) Geometrical Drawing (Lower)

**8. Mode of submitting Application:-** Candidates shall register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered shall apply by logging on to their profile using their User-ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card, if required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile. They must quote the User -ID for further communication with the Commission. Application once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of notification will be summarily rejected. Documents to prove qualification, Experience, Community, age etc have to be produced as and when called for.
