The Ranked List prepared in pursuance of this notification is intended to make recruitment to the backlog vacancies earmarked for the various categories and PH groups as per <u>GO (P) No 7/2011/SWD dated 24/01/2011</u> and will remain in force for a maximum period of three years subject to the condition that the ranked list will cease to exist as and when candidates are advised and appointed against the above mentioned vacancies. Rules 14 to 17 of Part II, KS&SSR are not applicable to this selection.

Candidates will be advised and appointed against the above mentioned vacancies and also against the backlog vacancies, if any, reported by the Appointing Authorities as earmarked in GO(P) No 7/11/SWD dated 24/01/2011.

Selection to the above-mentioned vacancies will be made from among the (Locomotor Disability/Cerebral palsy, Hearing impairment, Low vision) PH categories found suitable for the post as per existing government orders and vacancies will be apportioned among these categories in the ratio 1:1:1.

- 5. Method of appointment : Direct Recruitment from among the PH (Locomotor Disability/Cerebral Palsy, Hearing Impairment, and Low Vision) candidates only.
 - **Note:-** Application submitted by candidate other than those belonging to PH (Locomotor Disability/Cerebral Palsy, Hearing Impairment, Low Vision) category will be rejected. Individual rejection memo will not be sent to them.

6. Age limit

: 1. Hearing Impairment and Low Vision candidates:- 18 - 50; Only candidates born between 01.01.1996 and 02.01.1964 (both dates included) are eligible to apply for the post.

- Locomotor Disability/Cerebral Palsy candidates
 18 46. Only candidates born between
 01.01.1996 and 02.01.1968 (both dates included) are eligible for this post.
- **7. Qualifications:-** Should possess any one of the following qualifications.
 - (a) Group Certificate under KGTE or equivalent Examinations.

Note:- Group Certificates will include all the four groups viz. Building Drawing, Building Construction, Survey and Irrigation.

OR

A pass in eight subjects, namely,

i) Surveying and Leveling (Higher)
ii) Applied Mechanics (Higher)
iii) Building Material and Construction (Higher)
iv) Hydraulics and Irrigation (Higher)
v) Building Drawing and Estimating (Higher)
vi) Earth Work and Road Making (Higher)
vii) Geometrical Drawing (Lower) or Practical Plane and Solid Geometry (Lower)
viii) Mensuration (Lower)

- **b)** Diploma in Craftsmanship in the trade of 'Draftsman (Civil)' or 'Surveyor' obtained after 18 months course (followed by 6 months practical training) at the Industrial Training Institutes/Centres conducted by the Government of India, Ministry of Labour.
 - **Note**:-1) Candidates who have successfully completed the Industrial Training of 18 months will also be treated as qualified even if they have not completed the period of practical training. But their appointments will be treated as provisional and will be regularised only after the completion of six months practical training.
 - 2) Diploma in Craftsmanship (Trade Test Certificate) in the Trade of Draftsman (Civil) awarded to private candidates without insisting on six months practical training will be treated as an alternative qualification for direct recruitment to the post of II Grade Draftsman.
- c) Diploma in Civil Engineering (2 year course) of the Women's Polytechnic of the State.

Note:- Rule 10 (a)(ii) of Part II, KS & SSR is applicable.

- 8. **Mode of submitting Application:-** Before applying for the post, candidates shall register as per "ONE TIME REGISTRATION" with the official website of Kerala Public Service Commission 'www.keralapsc.gov.in'. Those who have registered shall apply by logging in to their profile using their User-Id and Password. No application fee is required.
