Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

1. **Department** : Kerala Vocational Higher Secondary Education
2. **Name of post** : Vocational Teacher – Live Stock Management (NCA-OX)
3. **Scale of pay** : ₹ 19,240 - 34,500/-
4. **Number of vacancy** : 1 (one)

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the above vacancy earmarked for OX Community, but remain unfilled due to paucity of candidates during the currency of the ranked list published on 17.04.2007 for the post.

5. **Method of appointment** : Direct Recruitment (from among OX community only)

**Note :-** The applications submitted by candidates other than OX community will be summarily rejected. No rejection memo will be issued to these candidates.

6. **Age limit** : 23-43. Only candidates born between 02.01.1970 and 01.01.1990 (both dates included) are eligible to apply for this post. [For conditions regarding the age relaxation, please see Para 2 of the General Conditions except para 2 (i)]

7. **Qualifications** : -

Degree in Veterinary Science and Animal Husbandry with not less than 60% marks from Kerala Agricultural University or an equivalent qualification.

- Note :- (i) In the appointment of Vocational Teacher preference will be given to persons having additional qualification of Diploma in Computer Application from a recognized institution.
- (ii) All the Educational Qualifications for teaching posts should be one acquired after a regular course of study from a recognised University in Kerala or recognized as equivalent thereto by any of the Universities in Kerala.

**8. Method of submitting Applications :-**

Before applying for the post, candidates shall register as per 'ONE TIME REGISTRATION' scheme through the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)'. Candidates are responsible to ensure correctness of the personal information and secrecy of password and they shall keep in mind the User Id for further communication with the Commission. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected. Documents to prove Qualification, experience, community age etc have to be produced as and when called for.
