- 6 Age limit : 18-39. Only candidates born between 02.01.1974 and 01.01.1995 (both dates included) are eligible to apply for the post. Candidates who were adult members of SC community converted to Christianity and their children belonging to OX Community are eligible for age relaxation up to 41 years.

7 Qualifications :

- 1) A pass in SSLC or its equivalent
- 2) Pass in Dental Hygienist course conducted in the Dental College, Thiruvananthapuram or its equivalent.

Candidates shall register as per 'ONE TIME REGISTRATION ' system on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates who have registered shall apply by logging in to their profile using their User- ID and password.
