FIRST NCA NOTIFICATION

Applications are invited online only from qualified Ezhava/Thiyya/Billava community candidates for selection to the following post. Applications must be submitted online through the official website of the Commission after "ONE TIME REGISTRATION". Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be taken within one year of the date of uploading. This instruction is applicable to photographs produced by candidates as per the direction of the Commission, at any stage of selection.

1. Name of Firm : State Farming Corporation of Kerala Ltd.
2. Name of Post : Field Supervisor Grade- II
3. Scale of Pay : ₹ 3050 – 5230/-
4. No. of vacancies : Ezhava/Billava/Thiyya – 2 (Two)

Note:-

- (1) The above vacancies existing at present. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above community but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 01.08.2011 for the post notified in the Gazette dated 12.11.2007 (Category No. 417/2007).
- (2) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of appointment : Direct Recruitment. (Candidates belonging from Ezhava/Billava/Thiyya community)

Note: Application submitted by candidates other than Ezhava/Billava/Thiyya will be summarily rejected. No rejection memo will be issued to such candidates.

6. Age : 18-39 .(Only candidates born between 02/01/1975 and 01/01/1996 (both dates included) are eligible to apply for this post. (Including the relaxation as per para 2(i) of the General Conditions).

Note:- The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in, subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

7. Qualifications:

SSLC or equivalent and certificate in Agriculture from a Government recognized institution or equivalent qualification.

Note: Rule 10 (a)ii of Part – II of KS&SSR is applicable.

8. Mode of submitting applications:-

Candidates shall register as per “ONE TIME REGISTRATION” system on the official website of Kerala Public Service Commission ‘www.keralapsc.gov.in’ for applying for the post. Those who have already registered can apply by logging in to their profile using their User ID and password. Candidates shall click on the ‘Apply Now’ button of the respective post in the Notification link for applying for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile if required by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of the password. Before applying for a post, candidates must ensure the correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove qualification, community, age, etc. have to be produced as and when called for.
