- (i) In the absence of Scheduled Caste Candidates, Scheduled Tribe candidates will also be considered.

  - (iii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.

- (v) The candidates belonging to above reservation communities shall submit application for this post to the districts concerned where the vacancy is in existence for their respective communities and shall note the name of that district against the relevant column in the online application. Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (vi) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

2. Ayurveda Colleges

(i) Scheduled Caste. 19-41. Candidates born between 2.1.1973 and 1.1.1995 (both dates included) are only eligible to apply for this post.  
(Including the relaxation as per para 2(i) of the General Conditions)

(ii) LC/AI, Muslim, OBC, Ezhava. 19-39. Candidates born between 2.1.1975 and 1.1.1995 (both dates included) are only eligible to apply for this post.  
(Including the relaxation as per para 2(i) of the General Conditions)

8. Mode of submitting Applications :-
