Applications are invited online only by “ONE TIME REGISTRATION” from qualified candidates belonging to Muslim/Mappila community in the State of Kerala for selection to the under mentioned post in Kerala Government service.

1. **Department** : **Collegiate Education**
2. **Name of Post** : **Lecturer in Statistics**
3. **Scale of pay** : **U.G.C. Scale**
4. **Number of vacancies** : **Muslim/Mappila - 3**

Note:- The above vacancies are now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above community but remains unfilled due to the paucity of candidates during the currency of the Ranked list published on 08.06.2010 for the post.

5. **Method of appointment** : **Direct Recruitment** (Only from candidates belonging Muslim/Mappila reservation group)

NOTE: *Applications of candidates belonging to communities other than the above will be summarily rejected. Individual rejection memo will not be sent to them.*

6. **Age** : **22-43.** Only candidates born between 02.01.1971 and 01.01.1992 (both dates included) are eligible to apply. [For other conditions regarding age relaxations, please see Para 2 of the general conditions of the Gazette notifications, excluding para 2(i)(ii)(iii)(iv)]

7. Qualifications

1. Masters Degree in the concerned subject (Statistics) with not less than 55% marks or its equivalent and good academic record .
2. Must have passed a Comprehensive Test in the concerned subject specifically conducted for the purpose by UGC or any agency duly constituted by the state government in this behalf. When qualifications are being equal, preference shall be given to those candidates who possess adequate knowledge in Malayalam.

Note: (i) For PhD holders who have passed Masters Degree prior to 19.09.1991, 50% marks for Masters Degree shall be sufficient.

(ii) Candidates who have obtained Ph.D Degree in the concerned subject are exempted from passing the NET examination
(G.O.(MS)No.86/07/H.Edn dated 19.06.2007)

- (iii) For recruitment to various posts under these rules, Degrees awarded by the Universities recognized by UGC alone shall be considered.
- (iv) The conditions laid down in KS & SSR Part II Rule 10(a)ii are applicable.

8. Mode of submitting Applications:-

Before applying for the post, candidates shall register as per “ONE TIME REGISTRATION” on the Official website of Kerala Public Service Commission www.keralapsc.gov.in. Those registered can apply by logging in to their profile using their User-ID and Password. No application fee is required. Candidates can view, rectify defects and have print – outs of the details on the registration card by clicking the link **Registration Card** after entering the Home Page. Candidates are responsible for the correctness of the personal information and secrecy of password and they shall quote the user ID for further communication with the Commission. Applications which are submitted not in accordance with the instructions given on the website will be summarily rejected. Documents to prove qualification, age, community etc have to be produced as and when called for.
