Applications are invited Online only from qualified candidates for Ezhava Community of Kerala State for appointment in the undermentioned post in Kerala Government Service. Before applying for the post the candidates shall register as per One Time Registration Scheme through the official website of Kerala Public Service Commission.

1. **Department** : MINING AND GEOLOGY
2. **Name of post** : DRILLER

5. **Method of appointment** : Direct Recruitment (from candidates belonging to Ezhava / Thiyya / Billava community only)

6. **Age limit** : 18-39 Only candidates born between 02.01.1975 and 01.01.1996 (both dates included) are eligible to apply for this post. Including the relaxation as per para 2(i) of the General Conditions.

7. **Qualification** :
 1. Must have completed the SSLC course of study.
 2. Must possess practical experience for a period of not less than 5 years in Diamond Core Drilling machines of different capacity with atleast 2000 metres of drilling experience in various formations.
 3. Must have knowledge in the maintenance of diamond core drills and pumps and must be able to maintain records related to running of drills bore hole logs and bit histories.

Note: 1) Proficiency in Drilling to be tested at the time of selection.
