Applications are invited online only under '**ONE TIME REGISTRATION SCHEME**' from qualified candidates belonging to the reservation group of communities in the state of Kerala (specified in the table given under item 4 below) on NCA vacancies for selection to the under mentioned posts in Kerala Government Service.

Note:- *The above vacancies are now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for the above communities but kept unfilled due to the paucity of candidates during the currency of the Ranked List published on 12.08.2009 for the post consequent to notification published under Cat.No.281/2007 in the Gazette dated 04.09.2007. This II NCA Notification is issued due to the non availability of sufficient candidates belonging to the above mentioned reservation groups in response to the first NCA notification published as per Category No 299/2010 in the Gazette dated on 30.10.2010.*

- 5. Method of appointment** : Direct Recruitment (from Muslim/Mappila and Latin Catholic/AI communities only)

Note:- *Applications submitted by candidates other than those belonging to Muslim/Mappila and Latin Catholic/AI communities will be rejected. Individual rejection memos will not be issued to them.*

- 6. Age limit** : 18-39, only candidates born between 02/01/1975 and 01/01/1996 (both dates included) are eligible to apply for the post. (Including relaxation mentioned in para 2 (i) of General Conditions)

(For conditions regarding age relaxation please see Para 2 of the General Conditions)

Note: Persons who have (as per GO(MS)357/76/Health dated, 27.09.1976) undergone successful Training in the Artificial Limb Centre attached to the Medical College, Thiruvananthapuram under Half a Million Job Programme will be eligible for relaxation of five years in the upper age limit.

7. Qualifications:-

- 1) Pass in SSLC
- 2) Candidates who have completed certificate course in Prosthetics and Orthotics conducted in the institution recognized by the Rehabilitation Council of India.

OR

Bachelor Degree/Diploma in Prosthetics and Orthotics conducted by institution recognized by the Rehabilitation Council of India

In the absence of 1&2 above

Candidates who have successfully completed ITI Trade in Carpentry, Sheetmetal and Fitter. On appointment they will be considered trainee for one year and they will be given the salary of minimum of scale of pay of the post.

Note:- Rule 10 (a)ii of Part II, KS&SSR is applicable.

8. **Mode of submitting Application:-** Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the provisions of the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc have to be produced as and when called for.
