1. **Department** : Various Departments.
2. **Name of post** : Confidential Assistant Gr.II

Note:-

- (i) Applications submitted by candidates belonging to the community other than that notified, will summarily be rejected. No rejection memo will be issued.
- (ii) Ranked List will be prepared in pursuance of this notification shall remain in force until candidates are advised and appointed against the NCA turns identified as unfilled during the currency of the Ranked Lists published for the post in the following districts. Candidates will be advised from the Ranked List for appointment against the head quarters vacancies also. Such candidates will be eligible for transfer as per the terms and conditions in G.O.(MS) No. 442/80/GAD dated 26.09.1980.

(iii) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in GO(MS) No. 154/71/PD dated, 27.5.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5years continuous service from the date of commencement of service in the former District. Even if transfer is allowed after 5 years, it will be subject to the rules in GO (MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment from candidates belonging to the above mentioned community.
6. Age limit : 18-41 Candidates born between 02.01.1973 and 01.01.1996 (both dates included) only are eligible to apply.
(For other conditions regarding age relaxation, please see para 2 of the general conditions except para 2 (i).

7. Qualifications:

1. Pass in SSLC or its equivalent.
2. Lower Grade Certificate in English Typewriting (KGTE) and Computer Word Processing or its equivalent (G.O.(P) No. 17/2005/P&ARD dated 09.05.2005).
3. Lower Grade Certificate in Malayalam Typewriting (KGTE) or its equivalent.
4. Lower Grade Certificate in Short Hand English (KGTE) or its equivalent.
5. Lower Grade Certificate in Short Hand Malayalam (KGTE) or its equivalent.

Note:-

Those who have passed KGTE Typewriting (English) before January 2002 should produce separate certificate in Computer Word Processing or its equivalent. Certificate in Computer Word Processing issued by Central/State Government Departments, Agencies, Societies, Universities after successfully completing course of study not less than three months duration are considered as equivalent. Certificates issued by Typewriting Institutions and IMC Certificates will not be accepted.

8. Method of submitting applications:-

Candidates must register as per “ ONE TIME REGISTRATION” on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' . Those who have registered shall apply by logging on to their profile using their user ID and password. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link **Registration Card** . Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile and they shall quote the User Id for further communication with the Commission. Application once submitted will be received as provisional and cannot be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.
