1st NCA NOTIFICATION

Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

1. Name of Firm : Plantation Corporation of Kerala Ltd./
State Farming Corporation of Kerala Ltd.
2. Name of Post : Compounder (Pharmacist)/Compounder
3. Scale of Pay : Scale of pay as prescribed for the post by
the concerned institution
4. No. of vacancies : OBC - 1 (One)

Note:-

- (1) The above vacancy is now in existence. The Ranked List published by the Commission in pursuance to this notification will be valid until candidates are advised and appointed against the vacancy earmarked for OBC communities, but remain unfilled due to paucity of candidates during the currency of the Ranked List published w.e.f.19.10.2010.
- (2) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of appointment : Direct Recruitment from candidates
belonging to OBC community.
6. Age :18-38. (Only candidates born between
02/01/1975 and 01/01/1995 (both dates
included) are eligible to apply for this
post.

- Note:-**1. Applications submitted by the candidates other than the community mentioned in this notification will be rejected and individual rejection memo will not be sent to them.
2. The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

2. Diploma in Pharmacy or Compounding certificate issued by the Government of Kerala or equivalent.

Candidates shall register as per “ONE TIME REGISTRATION” system on the official website of Kerala Public Service Commission ‘www.keralapsc.gov.in’ for applying for the post. Those who have already registered can apply by logging on to their profile using their User ID and password. Candidates shall click on the ‘Apply Now’ button of the respective post in the Notification link for applying for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile if required by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of the password. Before applying for a post, candidates must ensure the correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove Qualification, Community, Age, etc. have to be produced as and when called for.
