The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies reported to the Commission in writing during the period of currency of the list.

Note:-

3% of the vacancies shall be reserved for Physically Handicapped candidates (Category:- Locomotor disability/Cerebral Palsy,Low Vision, Hearing impairment)for recruitment to the post as per GO(P)No.43/2009/SWD dated 13/10/2009.

5. Method of appointment : Direct Recruitment

Note:-

Persons appointed to the above post shall be liable notwithstanding , at the time of requisition, they are holding higher appointments, to serve for a minimum period of 4 years(including the period spent on training)in the Defence Services or on assignment relating to Defence efforts anywhere in India or abroad if so required. The liability to serve in the Defence Service will be limited to the first 10 years of service

and will not ordinarily apply to persons above 40 years of age.

6. Age limit : 21-40, only candidates born between 02/01/1973 and 01/01/1992(both dates included) are eligible to apply for the post.

7. Qualifications

Degree in Electrical Engineering of the Kerala University or its equivalent.

8. **Mode of submitting Application:-** Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc have to be produced as and when called for.
