Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

1. Name of concern : District Co-operative Bank
2. Name of post : Driver
3. Scale of pay : 8100- 20475
4. No. of vacancies : District wise
Malappuram – 1 (One)
Idukki -1 (One)
Palakkad – 2 (Two)

50% of the vacancies of the post shall be filled up from this category .

- Note:-
- (i) Candidates shall apply through online facility provided in the website of Kerala Public Service Commission. Conventional type application will be summarily rejected
 - (ii) Separate Ranked list will be prepared for each district in pursuance of this notification. The Ranked Lists thus prepared and published by the Commission, shall remain in force for a minimum period of one year, and maximum period of three year subject to the conditions that the said lists will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidates is advised from the ranked list till the expiry of the period of three years the duration of the Ranked List shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.

- (iii) Selection in pursuance of this notification will be made on a District wise basis. Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her. Candidates should note the name of the concerned District against the relevant column of the online application.

Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment
6. Age limit : 18-37 , only candidates born between 2.1.1976 and 1.1.1995 (both dates included) are eligible to apply for this post. OBC and SC/ST Candidates are eligible for usual age relaxation.

Note

- 1 For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years. please see para(2) of the General Conditions under Part II of this notification.
- 2 Relaxation of age will be allowed to all provisional employees of the twenty nine Co-operative Institutions mentioned in G.O. (P) No.41/98 dated 9.3.1998 (Whether they continue in service or relived from service) who have been appointed through the Employment Exchange to the extent of their provisional service provided they possess a minimum service of one year in the provisional appointment. The maximum period of relaxation allowed to such persons will be five years. Once they get appointment on regular basis, the concessions will not be available to further appointment to any post. The candidates who are entitled to the above concession shall note the details there of in the respective columns of the applications and submit a certificate (original) obtained from the Head of Office or Head of Department or Appointing Authority of the Co-operative Institutions concerned when the commission called for. The Certificate should contain all the relevant particulars such as the post in which the applicant has/had provisional service, the scale of pay, name of the Co-operative Institution in which he/she has/had worked, the date of commencement of provisional service and the date of termination of the provisional service. It should also be noted in the certificate that the applicant is not holding regular appointment under the Co-operative Institutions. The original certificate thus produced will not be returned to the candidate.

7. Qualifications:

- 1) A pass in standard VII
- 2) Must possess a Light Duty Vehicle driving license of at least three years standing and Driver's Badge.

Note:- Candidates should possess current Driving License throughout all the stages of selection as on the last date for receipt of application, Practical test, Interview.

3) Medical Fitness:-

- (a) Ear-Hearing should be perfect.

- (c) Nervous System-Perfectly normal and free from any infectious diseases.

Note: a) Candidates called for practical Test will have to produce a medical certificate in the prescribed form in original containing all relevant details as required in para 7 (except 3 b) above from a Medical Officer not below the rank of an Assistant Surgeon. A medical certificate regarding eye sight as regards 3 (b) above from an Ophthalmologist in Government Service also will have to be produced.

b) The candidates will have to furnish the full details regarding the Driving Licence in relevant column (Qualification) of the application form.

c) Physically Handicapped persons are not eligible to apply for the post.

- d) Candidates should possess a current Driving licence on the last date of receipt of application and on the date of practical Test and on the date of interview,if ever an interview is conducted.
- e) Practical test including H-Test to assess the proficiency in driving will be conducted by K.P.S.C .Only those who pass the ground Test will be considered for road test.

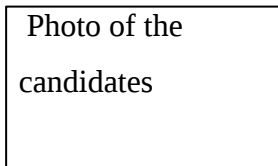

Specification for each eye should be stated separately. Special attention should be directed to the distant vision. Required standard of vision are as follows.

8. Mode of submitting Applications:-

Candidates shall register as per 'ONE TIME REGISTRATION ' system on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates who have registered shall apply by logging in to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link for applying for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile by clicking the link Registration Card, if required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile. They must quote the User- ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove qualification, experience , community, age etc. have to be produced as and when called for .
