Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

1. Department : Ayurveda Medical Education
2. Name of Post : Lecturer in Agadathanthra & Vidhi Ayurveda
3. Scale of Pay : ₹ 22360 - 37940
4. Number of vacancies : Muslim – 1 (One)

The above vacancy is now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies ear marked to the Muslim communities but remains unfilled due to the paucity of candidates during the currency of the Ranked List published on 28/01/13 for the post(Category No.358/2011) Gazette date 28/10/2011.

5. Method of appointment : Direct Recruitment (from among Muslim Community only)

Note:-

Application submitted by candidates belonging to other than Muslim Communities will be rejected. No rejection memo will be issued to them individually.

6. Age limit : 20-39, only candidates born between 02/01/1974 and 01/01/1993(both dates included) are eligible to apply for the post. (Including relaxation in para 2(i) of the General Conditions)

(For other conditions regarding the age relaxation please see Part 2 of the General Conditions)

7. Qualifications:-

- a) A post Graduate Degree in Ayurveda in the concerned subject, from any of the Universities in Kerala or from any other University recognised by any of the Universities in Kerala.
- b) Permanent 'A' Class Registration with Travancore – Cochin Medical Council (Council of Indigenous Medicine)

Note:-

- 1) If Post Graduate qualification holders in concerned subject is not available the candidates with Post Graduate Degree in Kayachikitsa

- or Dravyaguna for Agadathanthra shall be admissible.
- 2) In the absence of persons with Post Graduate Degree in the concerned subject, person with Graduation will be considered.

9. Mode of submitting Application:-

Before applying for the post, candidates should register as per “One Time Registration” Scheme through the official website of Kerala Public Service Commission ‘www.kerala.psc.gov.in’. Those who have already registered can apply by logging into their profile using his/her User-ID and password. No application fee is required. Candidates can view, rectify defects and print the details in the registration card by clicking the link **Registration Card** after entering the home page. Candidate are responsible to ensure correctness of the personal information and secrecy of password and they shall keep in mind the user ID for further communication with the Commission. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected. Documents to prove qualification age, community etc have to be produced as and when called for.
