FIRST NCA NOTIFICATION

Applications must be submitted online through the official website of the Commission after 'ONE TIME REGISTRATION'. Candidates who have already registered can apply through their profile.

1. Department : Medical Education Department
2. Name of Post : Senior Lecturer in Community Medicine
3. Scale of Pay : As per UGC Norms
4. Number of vacancy : Ezhava/Thiyya/Billava – 1 (One)

The above vacancy is now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancy earmarked for the Ezhava community but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 08/12/2009 for the post (Category No.251/09).

5. Method of Appointment : Direct Recruitment (from among Ezhava/Thiyya/Billava Communities only). Applications of candidates other than Ezhava community will be rejected. Individual rejection memo will not be issued.
6. Age Limit : 21-49 (Only candidates born between 02/01/1964 and 01/01/1992 (both dates included) are eligible to apply for the post.

(Including the relaxation as per para 2(i) of the General Conditions)

Note:- For conditions regarding other age relaxation please see para 2 of the General Conditions except para 2 (i)

7. Qualifications :

- (1) MD (Community Medicine) /MD (Social and Preventive Medicine)/DNB (Community Medicine)
- (2) Permanent Registration under Travancore Cochin Medical Council

NOTE:

- 1) DNB qualifications must be acquired from a Medical College, which is recognized by any of the Universities in Kerala
- 2) Provisional Registration with any Medical Council will not be accepted.
- 3) Those who are appointed in the post should serve for four (4) years during the first ten(10) years of their service (including the period of training) anywhere in India or any other foreign country under defence services connected with defence, if required. Those who have completed 45 years of age are exempted

from the above compulsory Military service.

(The qualification should be acquired on or before the last date of receipt of applications)

8. **Mode of Sending Applications:-** Candidates must register as per 'ONE TIME REGISTRATION ' scheme through the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in for applying for the post. Those who have already registered can apply by logging in to their profile using their User- ID and password. Candidates must exclusively click on the 'Apply Now' button of the respective posts in the Notification link for applying to a post. No application fee is required. Candidates can view and print the details in the profile by clicking the link Registration Card, if required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile. They must quote the User- ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Applications will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove Qualifications, experience, community, age etc. have to be produced as and when called for .
