**Note:- (i)** Conventional type applications will be summarily rejected. Candidates shall apply online only to [www.keralapsc.gov.in](http://www.keralapsc.gov.in)

**(ii)** Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued.

**(iii)** Separate Ranked lists will be prepared for each district in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above communities, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following districts.

- (iv) Reservation community candidates should submit application for the post to the concerned district officer where the vacancy is existing for their respective communities and note the name of that district against the relevant column of the application. Applications should not be sent to more than one district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.( Ms)No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another District unless he/she completes 5 years continuous service from the date of commencement of service in the former District. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O. (Ms)No.4/61/PD dated 02.01.1961. Candidates already in Government Service holding this post, in any one district are prohibited from applying again for this post but they can apply to higher posts when notified.

**5. Method of Appointment** : Direct Recruitment (From candidates belonging to, Viswamarma, Hindu Nadar Scheduled Tribe and Dheevera communities only). In the absence of candidates belonging to ST community, candidates belonging to SC will be considered.

**6. Age Limit** :18-45, Only candidates born between 02.01.1968 and 01.01.1995 (both dates included) are eligible to apply for this post in the case of ST community. 18-43. In the case of Viswakarma, Dheevera, Hindu Nadar communities, candidates born between 02.01.1970 and 1.1.1995 (both dates included) are eligible to apply for this post(including the relaxation as per para 2(i) of General conditions]

**Note:-** For conditions regarding other age relaxation please see para 2 the general conditions. except 2(i).

**7. Qualifications:-**

A Degree in Arabic conferred or recognized by the Universities in Kerala

OR

A Title of Oriental Learning in Arabic awarded or recognized by the Universities in Kerala.

OR

A pass in Pre-Degree with PartIII Arabic (Special optional) of the Calicut University.

OR

A pass in SSLC Examination conducted by the Commissioner for Govt. Examinations, Kerala with Arabic under part I and II first language.

OR

A) A pass in SSLC Examination conducted by the Commissioner for Government Examinations, Kerala or its equivalent and any one of the following qualifications.

B) 1) A pass in Arabic Munshi Examination (Higher) conducted by the Commissioner for Government Examinations, Kerala.

OR

2) A pass in Arabic Munshi Examination (Lower) conducted by the Commissioner for Government Examinations, Kerala

OR

3) A pass in Arabic Teachers Examination conducted by the Commissioner for Government Examinations, Kerala

OR

4) A pass in Arabic Entrance Examination of the Kerala /Calicut Universities.

**8. Special concessions regarding Appointment and age limit:**

(ii) Preference will be given as laid down in GO(MS)No.50/70/PD dated 12.02.1970 and GO(MS)No.9/78/G.Edn. Dated 21.1.1978 to the Wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in base establishment are included under the terms of Jawans. Such facts should be noted in the space provided for in the online application form. Wives of Jawans should note in the application that they are wives of Jawans. Such candidates should obtain proper certificates from the Officer commanding stating the name, Military rank and Military address of their husbands and produce the same as and when required by the Commission [GO(MS)No.509/64/Edn. Dated, 19.09.1964, GO(MS)No.614/65/Edn. Dated 9.11.1965 and GO(MS)No.243/66/Edn. Dated, 27.05.1966]

- ii)** First Class Scouts and Guides will be given preference in the matter of appointment as Teachers [GO(MS)No.122/75/G.Edn. Dated 27.05.1975 and G.O. (MS)No.50/70/PD dated 12.02.1970]

**Note:-** The candidates who claim concessions on the basis of any of the reason mentioned in para 2 of general conditions should select “Are you eligible for age relaxation as “Yes” on the online application and give details in the space following. Other wise the applications are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age. (See para 2 General Conditions).

### **9. Mode of Sending Applications:-**

Candidates shall register as per 'ONE TIME REGISTRATION ' system on the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' for applying for the post. Candidates who have registered shall apply by logging in to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link for applying for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile by clicking the link Registration Card, if required. Candidates are responsible for the correctness of the personal information and secrecy of the password. Before applying for a post, candidates must ensure the correctness of the information in their profile. They shall quote the User- ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove qualification, community, age etc. have to be produced as and when called for.
