7 **Qualifications** : Service not less than 5(Five) years as Village Extension Officer (5 Years service should be completed before last date fixed for receipt of application). The period of pre-service training will not be counted as service in this case

Training:- : The selected candidates shall subject to the existing rules undergo the Junior Officers Training for six months.

- 8 Mode of Submitting applications** (a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on

the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, Experience, community, age etc. have to be produced as and when called for.

- (b) If written /OMR/Online Test is conducted as part of this selection candidates shall submit a confirmation on writing the examination through their One Time Registration profiles . Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
