Note: - a) As 10% of the vacancies in the category of Accountant/ Cashier will be filled up by selection from among low paid employees included in the KTDC Last Grade Service (Posts included in item XVI of the Constitution) who possess the required educational qualification prescribed for direct recruitment and possess not less than two years of service, applications are invited from eligible low paid employees in KTDC. A test will be conducted for such candidates along with the selection test conducted for direct Recruitment and those who secure 40% marks and above in this test will be included in a separate Ranked List. They will be advised on the merit according to the availability of vacancies without observing the rules of reservation and rotation against (9th, 19th, 29th, 39th, 49<sup>th</sup>,59<sup>th</sup>, 69<sup>th</sup>, 79<sup>th</sup>,89<sup>th</sup>,99<sup>th</sup>) turns reserved for them. If sufficient number of candidates are not available to fill up this quota such vacancies will also be filled up by the candidates included in the ranked list prepared for the direct recruitment. In case candidates included in this list remain not advised, the name of such candidates will be included at the top of the ranked list of low paid employees subsequently prepared by the Commission.

- b) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advise was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.
- c) Every person appointed to this post shall be on probation for a period of 2 years on duty with in a continuous period of 3 years from

the date of joining duty.

Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile.
