5th NCA NOTIFICATION

Applications are invited from qualified candidates belonging to Scheduled Caste Converted to Christianity (SCCC) Community of Kerala State for appointment to the under mentioned post. Application must be submitted online through the Official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile.

1. Department : Homoeopathy
2. Name of post : Pharmacist Gr-II (Homoeo)
3. Scale of pay : ₹ 20,000-45,800/-
4. Number of vacancies : District wise

Note (i) Separate Ranked Lists will be prepared for the above districts in pursuance of this notification for the above community. Ranked Lists thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following districts or for three years from the date of finalization of the NCA Ranked List as per this notification whichever is earlier.

- (ii) The Candidates belonging to above reservation community shall submit application for the post to any one of the above District and shall note the name of that district against the relevant column of the Online application. Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against his/her.
- (iii) The fifth NCA notification is issued due to paucity of candidates belonging to the above community after the issuance of First NCA notification vide Category No.275/11, Second NCA notification vide Category No.118/13, Third NCA notification vide Category No.281/15 and Fourth NCA notification vide Category No.530/16.

- (iv) In case of change in Caste/Community noted in the SSLC book, candidates must claim their original caste in the application and shall produce Non-Creamy Layer Certificate issued by the Revenue Authorities and the original Gazette notification publishing the change of caste/community at the time of OTR verification for selection to the above post.
- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in the same department in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment :- Direct Recruitment (From candidates belonging to Scheduled Caste Converted to Christianity (SCCC) community of Kerala State Only).
Note: Application of candidates belonging to the community other than those belonging to SCCC Community will be summarily rejected. No rejection memo will be issued to these candidates.

6. Age Limit :- 18 - 39, Only candidates born between 02.01.1980 and 01.01.2001 (both dates included) are eligible to apply for this post. [Including the relaxation as per para 2 (i) of General Conditions].

In the case of Adult members of the Scheduled Caste and their children when such adult members are converted to Christianity the age limit will be 18-41, ie Such candidates should be born between 02.01.1978 and 01.01.2001 (both dates included). (including the relaxation as per Para 2(i) of the General conditions)

Note: For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification. [except para 2(i)].

7. Qualifications:-

- (i) Pass in S.S.L.C or its equivalent qualification.

- (ii) A pass Certificate obtained after successful completion of Nurse Cum Pharmacist Training Course (Homoeopathy) conducted by the Government of Kerala
OR
A pass in Certificate Course in Pharmacy (Homoeo) recognised by the Government .

*Note :- 1. KS&SSR Part II Rule 10 (a) (ii) is applicable for selection to this post.
2. Candidates claiming equivalent qualification should produce relevant Government Orders during OTR verification to prove that the qualification claimed is equivalent to the prescribed qualification for the Post.*

8 Mode of submitting Applications :-

Candidates must register as per “ ONE TIME REGISTRATION” scheme through the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have already registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, Experience, Community, age etc. have to be produced as and when called for. **Candidates who have Aadhar Card should add Aadhar Card as ID proof in their profile.**

9. Last date of receipt of applications : 05.02.2020 Wednesday upto 12 midnight.
10. If Written Test/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it.
