Applications are invited from qualified candidates for appointment to the under mentioned post in Kerala Government Service. Applications must be submitted Online through the official website of Kerala Public Service Commission after One Time Registration. Candidates who have already registered can apply through their profile.

1. Department : **Indian Systems of Medicine**
2. Name of Post : **Ayurveda Therapist**
3. Scale of pay : Rs. 19000-43600/-
4. Number of vacancies : **Districtwise**
Kannur - 02(Two)

Note:-

- (i) The above vacancies are now in existence. The Ranked list prepared and published by the Commission in pursuance of this notification shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against aforesaid vacancies and also against the vacancies, if any, reported during the currency of the list. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the Ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (ii) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in GO(Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years of continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in GO(MS) No. 4/61/PD dated, 2.1.1961. Candidates already in Government service holding this post in this Department in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (iii) In case of change in Caste/Community noted in the SSLC book, candidates must claim their original Caste/Community in the application and shall produce Caste/Community Certificate or Non-creamy Layer certificate as the case may be issued by the Revenue authorities and the original Gazette Notification publishing the change of Caste /Community at the time of OTR verification for selection to the above post.

5. Method of appointment : Direct Recruitment.

6. Age : 18-36. Only candidates born between 2.1.1983 and 1.1.2001 (both dates included) are eligible to apply for this post. Usual age relaxation will be given to SC/ST and Other Backward Communities.

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification.

7. Qualification :

(1) Pass in SSLC or equivalent qualification.

(2) Pass in Ayurveda Therapist Course conducted by Government of Kerala.

Note:-

(i) KS&SSR Part II Rule 10 a (ii) is applicable to selection to this post.

(ii) 3% of the vacancies reported for the post are reserved for Differently Abled candidates with Blindness/Low vision as per G.O(P)No.1/13/SJD dated 03.01.2013. **Differently Abled candidates with Locomotor Disability/Cerebral Palsy, and Hearing Impairment are not eligible to apply for the post.**

(iii) Candidates claiming equivalent qualification should produce relevant Government Orders during OTR verification to prove that the qualification claimed is equivalent to the prescribed qualification for the post.

8. Mode of submitting application:

Candidates must register as per ONE TIME REGISTRATION with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when

called for. **Candidates who have Aadhar Card should add Aadhar Card as ID proof in their profile.**

9. Last date of receipt of application: **05-02-2020** Wednesday upto 12 midnight.
10. If Written Test/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it.
11. Appropriate disciplinary action as per Rule 22 of KPSC Rules of procedure, will be taken against those candidates who submit application for the post with false claims of possession of prescribed qualification, experience etc and give confirmation for examination, irrespective of the fact that they have appeared or not for the examination.
