	iv) Candidates shall submit application for the post to the concerned district where the vacancy is existing for their respective community and shall note the name of that district against the relevant column in the online application. Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction, and if the candidate is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.																														
	v) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. Wives of Jawans should select “ Are you entitled to any priority” as yes on the online application and give the details in the space following. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).
	(ii)	First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS) No. 122/75/G.Edn. Dated 27.05.1975

	and GO(Ms) No.50/70/PD dated 12.2.1970).
<b>Note:-</b>	The candidates who are eligible for the above preferences or concessions in upper age limit or concessions by virtue of any of the reason mentioned in Para 2 of the General Condition should claim the same through the “weightage and preferences” link provided in their One Time Registration Profile and give details in the space provided. <b>9.</b>	<b>Mode of Sending Application :-</b>
	Candidates must register as per “ ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission ' <a href="http://www.keralapsc.gov.in">www.keralapsc.gov.in</a> ' before applying for the post. Candidates who have registered shall apply by logging in to their profile using their user ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking of the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates can view the details in their profile by clicking the link 'Registration Card' in their profile. A print out of the same can be taken if needed. Candidates are responsible for the correctness of the personal information and secrecy of password. Before final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User ID for further communication with the Commission. Application once submitted is provisional and cannot be deleted or altered after submission. Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, community, Age, etc., have to be produced as and when called for. <b>“Candidates who have AADHAAR card should add AADHAAR card as I.D. within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Ticket will be published in the examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it. Appropriate disciplinary action as per KPSC Rules of Procedure Rule 22 shall be taken against those candidates who submit applications with bogus claims of qualification regarding education, experience, etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
