Applications are invited from qualified candidates belonging to Dheevera Community of Kerala State for appointment to the under mentioned post. Application must be submitted online through the Official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile.

Note:-

- (i) Conventional type applications for the above post will be summarily rejected. Candidates shall apply only through online facility available at the Kerala Public Service Commission website viz www.keralapsc.gov.in
- (ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.
- (iii) A Ranked list will be prepared for the above district in pursuance of this notification for the above community. Ranklist thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked list published for the post in the following district or for three years from the date of publication of the NCA Ranked list as per this notification whichever is earlier.

- (iv) This is the I NCA notification for the post owing to non-availability of qualified candidates belonging to the above community. Candidates should submit the application for this post to the above district, where the vacancy is existing and should note the name of the concerned District against the relevant column of the online application.
- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (P) No. 36/91/P&ARD, dated 2.12.1991. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

(vi) If the caste/ community claim in the application differs from the caste/community noted in S.S.L.C., then such changes are to be published in the Gazette and the same should be produced along with the Community Certificate/Non Creamy Layer Certificate issued by the Revenue Authorities at the time of One Time Verification or as and when required by the Commission.

5. **Method of appointment:** Direct Recruitment (From candidates belonging to -Dheevera community **Only**).

6. **Age Limit** :**18-39** only candidates born between 02.01.1981 & -01.01.2002 (both dates included) are eligible to apply for this post.

Note: For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification.

7 **Qualifications:-**

1. Pass in S.S.L.C

2. Surveying and Levelling (Lower) KGTE/MGTE and pass in any two of the (A) following qualifications of KGTE/MGTE (Lower)

(a) Building Drawing and Estimating (Lower)

(b) Building materials and construction (Lower)

(c) Earth work and Road making (Lower)

(d) Hydraulics and Irrigation Engineering (Lower)

(e) Mensuration (Lower)

OR

(B) Certificate issued by the Director General of Resettlement and Employment in Surveyor Trade under the Craftsman Training Scheme.

OR

(C) ITI Draftsman Certificate in Civil/Mechanical

OR

(D) Diploma in Agricultural and Rural Engineering awarded by the Kerala Agricultural University or its equivalent recognized by the Kerala Agricultural University with a period not less than 2 years.

Note :- 1. *KS&SSR Part II Rule 10 (a) (ii) is applicable for selection to this post.*

2. *Those who claim equivalent qualification shall produce the respective Government Order to prove the claim at the time of One time Verification or as required by the Commission.*

8. **Mode of submitting Applications :-**

Candidates must register as per ONE TIME REGISTRATION scheme through the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have already registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their

profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, Experience, Community, age etc. have to be produced as and when called for. **Candidates who have Aadhar Card should add Aadhar Card as ID proof in their profile.**

- 9. Last date of receipt of applications : 30.12.2020 Wednesday upto 12 midnight.**
10. If Written Test/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it. As per Rule 22 of the KPSC Rules of Procedure, appropriate disciplinary action will be taken against those candidates who submit application for the post with false claims of possession of prescribed qualification, experience etc. and give confirmation for examination, irrespective of the fact that they have appeared or not for the examination.
