Note:

- (i) A Ranked List will be prepared for Palakkad district in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancy and also against the vacancies, if any, reported during the currency of the list. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (ii) Candidates shall submit application for this post to the Palakkad district and shall note the name of that district against the relevant column in the online application.
- (iii) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS)No.4/61/PD, dated 02.01.1961. Candidates already in Government service holding this post in this department in any other district are prohibited from applying again for this post.

(iv) In case of change in caste/community noted in the SSLC book, candidates must claim their original caste/community in the application and shall produce Caste/Community Certificate or Non Creamy Layer Certificate as the case may be issued by the Revenue Authorities and the original Gazette Notification publishing the change of caste/community at the time of OTR verification for selection to the above post.

6. Age

: 18-36. Only Candidates born between 02.01.1985 and 01.01.2003 (both dates included) are eligible to apply for this post. Other backward Communities and SC/ST candidates are eligible for usual age

7. Qualifications:-

- 1) A pass in Standard VII (New).
- 2) National Trade Certificate in the Trade of Electrician/Wireman.
- 3) Possession of Wireman's Licence.

Note:- KS & SSR part II Rule 10 a (ii) is applicable for selection to this post.

9. Mode of submitting applications:-

Candidates must register as per "ONE TIME REGISTRATION" with the of Official Website Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My Applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The Application will be summarily rejected if non-compliance with the notification is found in due course of processing.
