- (i) Conventional type applications for the above post will be summarily rejected. Candidates shall apply online only by One Time Registration to www.keralapsc.gov.in.
- (ii) A Ranked List will be prepared for the above district in pursuance of this notification. The Ranked List thus prepared and published by the Commission, shall remain in force for a minimum period of one year and a maximum period of three years provided that the said lists will not continue to be in force if a new list is published after the expiry of the minimum period of one year. Candidates will be advised for appointment against aforesaid vacancy and also against the vacancies, if any reported during the currency of the list. In case no candidate is advised from the ranked list till the expiry period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier
- (iii) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(Ms) No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O.(Ms) No.4/61/PD dated 02.01.1961. Candidates already in Government service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (iv) Candidates should submit applications for the post to the above district and should note the name of that district against the relevant column in the online application.

(v) If the Caste/Community claim in the application differs from the Caste/Community noted in S.S.L.C, then such changes are to be published in the Gazette and the same should be produced along with the Community Certificate/Non Creamy Layer Certificate issued by the Revenue Authorities at the time of One Time Verification or as and when required by the Commission.

Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference.
