Applications are invited online only from qualified candidates for appointment in the undermentioned post in Kerala Government Service. Before applying for the post the candidates should register as per **One Time Registration** through the official website of Kerala Public Service Commission. Candidates who have already registered can apply through their profile.

- 1. Department** : Ground Water
- 2. Name of Post** : Surveyor Grade II (Hydrogeology Branch)
- 3. Scale of pay** : ₹ 31,100-66,800/-
- 4. Number of vacancy** : 1 (One)

The above vacancy is now in Existence. The Ranked List of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the above mentioned vacancy and also against the vacancies if any, reported to the Commission in writing during the period of currency of the list.

- 5. Method of appointment** : Direct Recruitment
- 6. Age Limit** : (18-36) Only Candidates born between **02.01.1985** and **01.01.2003** (both dates included) are eligible to apply for the post.

- 7. Qualifications** : 1) Degree or Diploma in Civil Engineering
OR
2)(a) Pass in SSLC or its equivalent qualification
and
(b) ITI Trade Certificate in Surveyor Trade

- Note :
- 1 Rule 10 a (ii) of part II KS & SSR is applicable.
 - 2 Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Equivalency Certificate /Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

- 3 In the case of difference in original Caste/Community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy layer Certificate/ Community Certificate at the time of certificate verification.

8. Mode of Submitting applications:

(a) Candidates must register as per “ONE TIME REGISTRATION” with the Official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the '**Apply now**' button of the respective posts in the Notification Link to apply for the post. The Photograph uploaded should be taken after 31/12/2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a print out or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link ‘My applications’ in their profile. All correspondence with the commission regarding the application should be accompanied with the print out of the application.** The applications will be summarily rejected if non compliance with the notification is found in due course of processing. The Original documents to prove qualification, age, community etc have to be produced as and when called for.

(b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. Appropriate disciplinary action as per Rule 22 of KPSC Rules of procedure will be initiated against those candidates who gave confirmation for writing the examination by providing false claims about their qualification/experience.

(c) Candidates who have AADHAAR card should add AADHAAR card as ID proof in their profile.
