Applications are invited online only from qualified candidates belonging to the reservation group of Scheduled Tribe Community of Kerala State for appointment to the under mentioned post. Application must be submitted online through the Official website of the Kerala Public Service Commission after One Time Registration. Candidates who have already registered can apply through their profile.

1. **Department** : Homoeopathy

Notes:

(i) The above vacancy is now in existence. A Rank list will be prepared for above District in pursuance of this notification. Ranked List thus prepared and published shall remain in force for a period of three years from the date of publication of Rank list or until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to the paucity of candidates during the currency of the Ranked List published for the post in the district whichever is earlier.

- (ii) The candidates belonging to above reservation community shall submit application for the post to the concerned district and shall note the name of that district against the relevant column of the online application.
- (iii) The fourth NCA notification is issued due to the paucity of qualified candidates belonging to the above community after the issuance of first NCA notification vide category number 113/2018, second NCA notification vide category no.380/2019 and third NCA notification vide category number 363/2020.

- (iv) In case of change in caste/community noted in the SSLC book, candidate must claim their original caste/community in the application and shall produce Community Certificate issued by the Revenue authorities and the original gazette notification publishing the change of caste/community at the time of OTR verification for selection to the above post.
- (v) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in GO (MS) No.154/71/PD dated 27/05/1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O. (MS) No.4/61/PD. Dated 02.01.1961. Candidates already in Government service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher/lower posts when notified.

5. **Method of appointment**: Direct

Direct Recruitment (From candidates belonging to Scheduled Tribe community of Kerala State only. In the absence of Scheduled Tribe candidates, Scheduled Caste candidates will be considered for appointment)

Note: - Applications submitted by candidates belonging to the community other than SC/ST will be summarily rejected. No rejection memo will be issued to these candidates.

6. **Age**

: 18-41, ie, candidates born between 02.01.1980 and 01.01.2003 (both dates included) are only eligible to apply for this post. (Including the relaxation as per Para 2(i) of the General Conditions)

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 (fifty) years, Please see Para (2) of the General Condition under Part II of this notification [except para 2(i)].

7. Qualifications:-

i) Pass in S.S.L.C or its equivalent.

ii) A pass Certificate obtained after successful completion of Nurse Cum Pharmacist Training Course (Homoeopathy) conducted by the Government of Kerala / A pass in Certificate Course in Pharmacy (Homoeopathy) conducted by the Government of Kerala / its equivalent qualification recognised by the Government.

Note: - 1. KS&SSR Part II Rule 10 (a) (ii) is applicable.

2. Candidates claiming equivalent qualification should produce relevant Government Orders during OTR verification to prove that the qualification claimed is equivalent to the prescribed qualification for the Post.

8. Mode of submitting applications:-

Candidates must register as per ONE TIME REGISTRATION with the Kerala Public official Website of Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date on which the photograph was taken. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must guote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

9. **Last date of receipt of applications : 02.02.2022** Wednesday upto 12 midnight.

If Written Test/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination. 11. Appropriate disciplinary action as per Rule 22 of KPSC Rules of Procedure 1976 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
