- 6. Age limit : 19-44. Only candidates born between 2.1.1977 and 1.1.2002 (both dates are included) are eligible to apply for this post with usual relaxation to Scheduled Castes, Scheduled Tribes and other Backward Communities. (For other conditions regarding the age relaxation, please see Para 2 partII of the General Conditions).
- 7. Qualifications
  1. S.S.L.C or its equivalent qualification.
  2. (a) National Trade Certificate in the appropriate trade with three years experience in the trade after obtaining the certificate.

(b) National Apprenticeship Certificate in the appropriate trade with one year experience after obtaining the certificate.

#### OR

(c) Diploma in the appropriate branch of Engineering from a Government or Government Recognized polytechnic or its equivalent qualification.

Note:-The experience gained by a Workshop Attender in the trade can also be deemed to be qualifying experience in the trade for selection to this post.

Note:- 1. Rule 10 a (ii) of part II of KS&SSR is applicable.

- 2. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification
