Applications are invited online only by One Time Registration from qualified regular employees of the Member Societies affiliated to Kerala State Handloom Weavers Co-operative Society Limited belonging to Muslim community for appointment to the under mentioned post.

Note:-

- iii) *The selection in pursuance of this notification will be made on a statewide basis.*
- iv) *As per KCS rule 184 every person appointed to the post shall from the date on which he/she joins duty be on probation for a total period of 1 years within a continuous period of 2 years.*

- 5 Method of appointment : Direct Recruitment from eligible employees of the Member Societies affiliated to Kerala State Handloom Weavers Co-operative Society Limited belonging to Muslim community.
Note:- Applications submitted by candidates who are not regular employees of societies affiliated to Kerala State Handloom Weavers Co-operative Society Ltd and belonging to community other than Muslim will be rejected. Individual communication regarding the rejection of their applications for the above reason will not be issued.
- 6 Age : 18-50. Only candidates born between 02.01.1972 and 01.01.2004 (both dates included) are eligible to apply for this post.
- 7 Qualifications: 1 Must have 3 (three) years regular service in any cadre in the Member society affiliated to the Kerala State Handloom Weavers Co-operative Society Limited and should be in service of the Member society not only on the date of application but also on the date of appointment to the new post.

3 Knowledge of Cycling
