Applications are invited online only by One Time Registration exclusively from qualified candidates for selection to the under mentioned post in Kerala Government Service.

(i) One (01) vacancy each (DA-LowVision) in Kollam & Kottayam districts and Two (02) vacancies (DA-Low Vision, Hearing Impaired) in Kozhikode district for the Post of Part Time Junior Language Teacher (Arabic) LPS in Education Department set apart as per PWD Act 2016 due to the non availability of DA candidates in the previous Ranked Lists for this post, will be filled up from the candidates in the same DA Categories from the Ranked Lists published for the respective districts as per this Notification. If candidates are not available in the respective DA category, the vacancy will be filled up from other available DA categories and in the absence of DA candidates, the vacancy will be filled up from General Category.

(ii) One vacancy noted above against Thiruvananthapuram is NJD from DA Low Vision, will be filled up from the same category only in the Ranked List published as per this notification.

- Note:- (i) Candidates shall apply online only by One Time Registration on www.keralapsc.gov.in. Applications submitted in any other manner will be summarily rejected.
- (ii) Separate Ranked lists will be prepared for each district in pursuance of this notification. The Ranked lists thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists.
- (iii) Candidates shall submit application for the post to any one of the above mentioned districts where the vacancy is existing and shall note the name of that district against the relevant column in the online application. If applications are sent contrary to the above direction, and if the candidate is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.

- (iv) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. But as per the G.O.(P)No.12/96/ P&ARD dated 16.3.1996 the conditions of 5 years Service is not applicable for transfer to the districts Idukki, Wayanad and Kasaragod. The concession will be available only for getting transfer to these districts but not for getting transfer out of these districts. And these concession will be granted only once in the career of a Govt. Servant. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (v) 4% of the total vacancies reported shall be reserved for eligible Differently Abled candidates with disabilities as specified vide G.O(P)No.19/2020/SJD dated 25.08.2020 & G.O. (P)No.7/2022/SJD dated.28.10.2022

5. Method of appointment : Direct Recruitment

6. Age Limit : 18-40. Candidates should be born between 02.01.1983 and 01.01.2005 (Both dates included). SC/ST candidates and Other Backward Communities are eligible for usual age relaxation.

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification.

7. Qualifications:-

1 A degree in Arabic conferred or recognized by the Universities in Kerala.

OR

A Title of Oriental Learning in Arabic awarded or recognized by the Universities in Kerala.

OR

A Pass in Pre-Degree with Part III Arabic (Special Optional) of the Calicut University.

OR

A Pass in Plus Two, Part III Arabic (Optional) course conducted by the Board of Higher Secondary Examination in Kerala

OR

A pass in SSLC Examination conducted by the Commissioner for Government Examinations, Kerala with Arabic under Part I and Part II First Language.

OR

A pass in SSLC examination conducted by the Commissioner for Government Examinations, Kerala or its equivalent ; and any one of the following qualifications.

- 1) A Pass in Arabic Munshi Examination (Higher) conducted by the Commissioner for Government Examinations, Kerala.
- 2) A Pass in Arabic Munshi Examination (Lower) conducted by the Commissioner for Government Examinations, Kerala.
- 3) A Pass in Arabic Teachers Examination conducted by the Commissioner for Government Examinations, Kerala.
- 4) A Pass in Arabic Entrance Examination of the Kerala and Calicut Universities.

Note: In addition to the above qualifications, as per G.O. (Ms) No.8/19/G.Edn dated 14.01.2019, BA Arabic & Islamic History double main degree awarded or recognised by Universities in Kerala will also be considered as a qualification for the above said post.

- 2 Must have passed the Kerala Teacher Eligibility Test-IV (K-TET-IV) for this post conducted by the Government of Kerala

Exemption: (i) Candidates who have qualified CTET/NET/SET/M.Phil/Ph.D in the respective subjects and M.Ed are exempted from acquiring TET (G.O. (P) No. 145/16/G.Edn. Dated 30.08.16 , G.O. (P) No. 206/16/G.Edn. Dated 08.12.2016).

(ii) Candidates who have acquired KTET Category III are exempted from acquiring KTET Category IV [G.O.(Ms)No.109/22/GEDN dated. 24.06.2022]

Note :

1. As per Govt. Circular No.1866829/J3/2017/G.Edn dtd 09.03.2018, exemptions are given to those who have passed CTET Primary stage from KTET Category I and CTET Elementary stage from KTET Category II. Based on the above condition, CTET will not be considered against KTET Category III and IV.

2. As per G.O.(P) No 15/2020/G.Edn dated 09.10.2020, M.Ed which is prescribed as a substitute qualification for KTET need not be subject specific.

3.M.Phil in the concerned subject be the one awarded by any of the Universities in Kerala or recognised as equivalent by any of the Universities in Kerala.

4. Candidates should possess the minimum general educational qualification for the post viz, A pass in SSLC examination conducted by the Commissioner for Government Examinations, Kerala or its equivalent (G.O.(Ms)No. 232/2009/G.Edn. Dated 30.11.2009.)

5. Candidates claiming equivalent qualification should produce relevant Government Orders during verification to prove that the qualification claimed is equivalent to the prescribed qualification for the post.

6. Rule 10(a) (ii) of Part II KS&SSR will be applicable for this post.

Note:- In addition to the qualifications prescribed in the notification, the qualifications recognized by executive orders or standing orders of Government as equivalent to a qualification specified for a post, in the Special Rules or found acceptable by the Commission in cases where acceptance of equivalent qualifications is provided for in the rules and such of those qualifications which presuppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post. The copy of the Government orders declaring equivalent/higher qualifications shall be produced as and when required by the Commission .

8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT

(i) Preference will be given as laid down in G.O.(Ms) No. 50/70/PD dated 12.02.1970 and G.O. (Ms) No. 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term 'Jawans'. Wives of Jawans should select "Are you entitled to any priority" as "yes" on the online application and give the details in the space following. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (Ms) No. 509/64/Edn. Dated 19.09.1964, G.O.(Ms) No. 614/65/Edn. Dated 09.11.1965 and G.O (Ms) No. 243/66/Edn. Dated 27.05.1966).

(ii) Laboratory Attenders in the Departmental High Schools in the State who have rendered at least 5 years satisfactory service and who possess the prescribed qualification will be exempted from age limit. They should produce proper certificates from the Headmaster of the school specifying the date of commencement of their service and the total service put in by them as and when required by the Commission. The candidates who claim exemption on this basis will be considered only against vacancies to be filled up by open competition on the

basis of merit alone (G.O. (Ms) No.315/62/Edn. Dated 14.05.1962)

- (iii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O.(Ms)No.122/75/G.Edn. Dated 27.05.1975 and G.O.(Ms) No. 50/70/PD dtd 12.2.1970.)

Note:- The candidates who are eligible for the above preferences or concessions in upper age limit or concessions by virtue of any of the reason mentioned in Para 2 of the General Condition should claim the same through the “weightage and preferences” link provided in their One Time Registration Profile and give details in the space provided. The applications of candidates who are eligible for concession in upper age limit and who do not claim the same, are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age (see para 2 of General Conditions).

9. Mode of Sending Application :

Candidates must register as per ‘ONE TIME REGISTRATION’ with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2013. **Candidates creating new profile should upload the photograph taken within 6 months.** Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking of photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for. **Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile.**

12 Special Instructions to Candidates:

i) In the case of difference in Caste/ Community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette Notification in this regard, along with Non-Creamy Layer Certificate/ Community Certificate at the time of certificate verification.

ii) Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.

iii) Appropriate disciplinary action as per Rule 22 of the Kerala Public Service Commission Rules of Procedure, 1976 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc and are liable to be disqualified for being considered for a particular post or debarment from applying to the Commission either permanently or for any period or the invalidation of their answer scripts or products in a written/practical test or the initiation of criminal or other proceedings against them or their removal or dismissal from office or the ordering of any other disciplinary action against them if they have already been appointed, or any one or more of the above.

iv) If a Written Test/OMR/Online Examination is conducted as a part of this selection, candidates shall submit a confirmation for writing the examination through their 'One Time Registration' Profile. Such candidates alone can generate and download the Admission Ticket in the last 15 days till the date of test. The applications of the candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Ticket will be published in the examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it.
