Applications are invited online only by **One Time Registration** from qualified candidates are belonging to OBC Community for appointment to the under mentioned post in Apex Societies of Co-operative Sector in Kerala. Candidates who have already registered can apply through their profile.

1. **Name of Concern** : Apex Societies of Co-operative Sector in Kerala
2. **Name of Post** : **Driver**
3. **Scale of Pay** : **₹8825-25075 /- (PR)**
4. **Number of Vacancies** : **OBC -01 (One)**

Differently abled candidates are not eligible to apply for this post.

Note:

- 1) The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancy earmarked to the OBC Communities but remains unfilled due to paucity of candidates during the currency of the Ranked List published on 29.12.2022 for the above post notified under Category No. 410/2019. The rules of reservation as laid down in General Rules 14-17 of KS&SSR, 1958 will be followed for appointment from both the lists.
- 2) The selection in pursuance of this notification will be made on a statewide basis.

5. Probation : As per Rule 184 of KCS every person appointed to this post shall from the date on which he/she joins duty be on probation for a period of One year on duty within a continuous period of two years.

6. Method of appointment : Direct Recruitment (Only from the eligible employees belonging to OBC Category)

7. Age Limit : 18-43. Only candidates born between 02/01/1980 and 01/01/2005 (both dates included) are eligible to apply for this post.

8. Qualifications :

- 1.) Pass in Standard VII (New) or Equivalent Qualification.
- 2.) Must possess a Motor Driving Licence (LDV Licence) of at least three years standing and Driver's Badge. (The Driving Licence should be current at all stages of selection, viz, on the date of application, the last date for receipt of applications, practical test and interview).
- 3.) Proficiency in driving Light Duty Vehicle (To be proved at a Practical Test).
- 4.) Medical Fitness

(i) Ear : Hearing should be perfect.

(ii) Eye : (Both the Eyes)

Distant Vision	-	6/6 snellen
Near Vision	-	0.5 snellen
Colour Vision	-	Normal
Night Blindness	-	Nil

(iii) Muscles and Joints - No paralysis and all joints with free movements

(iv) Nervous System - Perfectly normal and free from any infectious diseases.

Note:

- 1) A practical test including H test to assess the proficiency in driving will be conducted by the Kerala Public Service Commission. Only those who qualify in the ground test will be considered for road test.
- 2) Candidates should produce a Medical Fitness Certificate from a medical officer not below the rank

of an Assistant Surgeon and a medical certificate regarding the vision obtained from an ophthalmologist in Government Service (in the prescribed form) as and when called for by the Commission. Form of Medical Certificate are given below.

Note :-

1. Rule 10 (a) (ii) of Part II KS&SSR is applicable for this selection.
2. In addition to the qualifications prescribed in the notification, the qualifications recognized by executive orders or Standing orders of Government as equivalent to a qualification specified for a post, the qualifications decided by the Commission as equivalent to the qualifications in the special rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post , shall also be sufficient for the post. The copy of the Government orders declaring equivalent / higher qualifications shall be produced as and when required by the Commission.

9. Mode of submitting applications :

(a) Candidates must register as per **ONE TIME REGISTRATION** with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User- ID and password. Candidates must refrain from creating multiple profiles, non-compliance of which shall lead to forfeiture of their candidature.

Candidates must click on the 'Apply Now' button of the respective posts in the Notification link to apply for a post. The photograph uploaded should be one taken after 31.12.2013. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the photograph. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. Candidates who create new profile should upload photograph taken within 6 months. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User- ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a print out or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link 'My Applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non compliance with the notification is found in due course of processing. Original documents to prove qualification, age, Community etc. have to be produced as and when called for.

(b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their profiles for One Time Registration. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

(c) Candidates who have AADHAAR Card should add AADHAAR Card as I.D proof in their profile.

10. Para 2(Excluding sub para 6), 5 and 6 of the General Conditions are not applicable to this post.

14. Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and Conditions are liable to be rejected. (b) (b) The selection to the above concern will be subject to the rules and regulations made by them from time to time.

15.
