FIRST NCA NOTIFICATION

Applications are invited Online only by ONE TIME REGISTRATION SCHEME from qualified candidates belonging to reservation group of Latin Catholic / Anglo Indian (LC/AI) Community in the state of Kerala against NCA vacancies for selection to the under mentioned post in Kerala Government Service. Before applying for the post, the candidates shall register as per One Time Registration Scheme through the official website of Kerala Public Service Commission. Candidates who have already registered can apply through their profile.

- 1. Department : Ayurveda Medical Education**
- 2. Name of Post : Assistant Professor in Rachana Sharir**
- 3. Scale of Pay : As per UGC Norms**
- 4. No. of vacancies : Latin Catholic /Anglo Indian -01 (One)**

The above vacancies are now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancy ear-marked for Latin Catholic/Anglo Indian community but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 19.08.2023 for the above post notified under category number 343/2021 vide gazette dated 15.09.2021. The selection in pursuance of this notification will be made on statewide basis.

- 5. Method of appointment :** Direct Recruitment (from among Latin Catholic /Anglo Indian Community only)
Note : Applications of candidates belonging to communities other than the above will be summarily rejected. Individual rejection memo will not be sent to them.
- 6. Age limit :** 20 – 49. Only candidates born between 02.01.1974 and 01.01.2003 (both dates are included) are eligible to apply for this post (For other conditions regarding the age relaxation please see Part 2 of the General Conditions)

7. Qualifications:-

- 1.** A post Graduate Degree in Ayurveda in the concerned subject from any of the Universities in Kerala or from any other University recognized by any of the Universities in Kerala.
- 2.** Permanent 'A' class Registration with Travancore-Cochin Medical Council (Council of indigenous Medicine).

Note:- 1. Post-graduate Degree in the concerned subject has been made compulsory for appointment by direct recruitment to the post of Assistant Professor.

- 2.** If post-graduate holders of the subject is not available, post-graduate qualification prescribed by Central Council of Indian Medicine shall be admissible for that subject from time to time. .KS & SSR Part II Rule 10(a)(ii) is applicable
- 4.** In addition to the qualifications prescribed in the notification , the qualifications recognized by executive orders or standing orders of Government as equivalent to a qualification specified for a post, in the Special Rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post , shall also be sufficient for the post. The copy of the Government orders declaring equivalent /higher qualifications shall be produced as and when required by the Commission.

8. Probation: Every person appointed to this post shall from the date on which he joins duty be on probation for a period of two years on duty within a continuous period of three years.

9. Mode of submitting Application:-

(a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for the post. The

photograph uploaded should be one taken after 31.12.2013. **Candidate who have created new Profile from 01.01.2023 should upload their Photograph taken within a period of 6 months.** Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link 'My applications' in their profile. All correspondence with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original Documents to prove qualification, experience, age, Community etc. have to be produced as and when called for. The profile correction made by the candidates themselves or through the office of the KPSC on request after the last date fixed for the receipt of applications will not be reflected in the application. Such corrections will come into effect only on the date on which corrections have been made.

- (b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets prior to 15 days of the Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The period regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their profiles and in the mobile phone number registered .
- (c) “Candidates who have AADHAR Card should add AADHAR as ID Proof in their profile.”

10. Special Instructions to Candidates :-

- (a) In the case of difference in Caste/Community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette Notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of certificate verification.
- (b) Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.
- (c) Appropriate disciplinary action as per Rule 22 of the Kerala Public Service Commission Rules of Procedure shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and are liable to be disqualified for being considered for a particular post or debarment from applying to the Commission either permanently or for any period or the invalidation of their answer scripts or products in a written/practical test or the initiation of criminal or other proceedings against them or their removal or dismissal from office or the ordering of any other disciplinary action against them if they have already been appointed, or any one or more of the above
