A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. A copy of the answer sheet will be issued to a candidate only once. Copies of OMR answer sheets invalidated due to any defect will not be issued.
